Correctional Education Research Committee

Chair, Rich Stempinski

- What is best meaning of recidivism?
 - o IDOC Recidivism: Returning to facility within 3 years after a conviction
 - IDOC recidivism rate is 47%
 - o Institutions retaining individuals for 6 months or more and return once released
 - County jail population is charged and not necessarily convicted
- Why can't people get approved for adult ed classes?
 - o They aren't allowed to have a known associate in the class with them
- State level office that deals with reentry
 - o Reentry skills facilities within DOC (e.g., Kewanee Center)
 - Includes yoga, adult ed, anger management
- Jails can lose students midway through their classes because they are sent to prison/back to the community
 - o They can't necessarily make it to classes at ICC because they don't have money for the bus

- ICC has a 4-week class that's paid for GED grads to transition them to credit or work
- John Howard Association
- Community follow-up is essential
 - Need a bridge/transitional component
 - o Disconnect between people who leave corrections and their parole area
 - o How does the One-Stop get involved?
- Community connections/adult transitions has gone away
- Ideal state:
 - o Individual leaves facility, connected to a community organization, assessed for needs
 - To get them a GED, you need to get to them in the first 30-45 days
- Department of Women's Justice Services at Cook County Jail: No longer operating
 - o Cook County has a program for pregnant women (as do other prisons)
- A Safe Haven has a women's reentry program
- For women, ability to go back home may be higher
 - o Men can't get on LINK
- Connect One-Stops to corrections and give information to families
- Parole and probation has to be paid for
- DOC is out of the loop regarding WIOA
- Facilities in Ohio had kiosks to register with their One-Stop system
- What is the connection between AE services inside and outside a facility?
- Each facility has a reentry summit twice a year
- Cannot track a person who goes into education after release because of privacy
- IDES has a program for ex-offenders (ask Mark Witterman)
