o It's an interesting, overwhelming time.

- o Reminder that ICCB Board meetings are open to all they are public meetings. We will be sure to alert you in the future if there is a specific Adult Education issue to be discussed at a Board meeting..
- The House Appropriations Hearing was on March 30th a good opportunity to speak to the Legislature. Representative Naomi Jacobson (Champaign) asked how we are serving our Adult Education students. This was a great opportunity for Karen to share our vision.
- The Senate Appropriation Hearing is to be held the first week of April.
- o The General Assembly is focusing on outcomes this year
- The good news in terms of our budget is that we have heard nothing about cuts in Adult Education. Our efforts seem to be working.

- With all that is going on ICCB has decided our approach will be only projects that do not require new data. We are way ahead of the curve in terms of data so we can focus on that strength instead of starting from scratch.
- o Jennifer Foster will speak at a House of Representatives staffers meeting in Washington, DC in May. This helps Illinois and helps us promote our Strategic Plan.

Jennifer Foster, Senior Director for Adult Education and Family Literacy

- o Thanks to staff and Service Center Network for all of their hard work. Our focus is on:
 - o Making sure that EBRI is part of what we do in Illinois
 - o Working on how we can expand Career Pathways
 - o Content Standards
 - Will release ABE/ASE content standards at Administrators Meeting in April
 - o Alignment of ABE/ASE standards with Common Core Standards (we are one of 48 states that have adopted these standards)
 - We measure up well in K-8 but we need to focus on 9 12 standards
 - With the changes in 9 12 standards we will need to provide more professional development to teachers.
 - We hope to see our students bypass remedial education
- New Grant Application
 - o DOL lots of hard work it will take all of us partnering together to get it done.
- o Ad Hoc Committees a lot going on with all of them
 - Support Services
 - Marketing
 - o Instructional Technology and Distance Education
- o GED Updates
 - o Possible new test in 2014
 - We are currently phasing in computer based testing
- o IACEA Awareness Day a success with 300 students, teachers and Administrators
- o State Directors Meeting Washington, D.C. in May
- o NRS measures
 - o Will be talked about at April Administrators Meeting
 - o We will be taking the NRS training that we received in DC and replicate it for the programs
 - o Assessment testing and learning outcomes must be looked at
 - o As we change cohorts with new NRS data, we will be able to move forward
- o ABE to Credentials Grant
 - o Asking us to infuse IBEST model or an IBEST 'like' model (which would mean we can give it our own flair)

- o Several people on design team from around the state if you are not a part of it yet, you may soon be asked to participate.
- o ABE students will actually enroll in courses that will provide college credit
- o If your program developed a Bridge program you will have an opportunity to be part of this project and there will be funds available for those colleges selected to participate
- o Very fast time line to be completed by November and then implementation begins
- o State Plan for Adult Education
 - o Draft copy available for review at this meeting not many changes
 - o Added Bridge Program, Common Core Standards, ABE to Credentials and IBEST information
