

## Annual Report Highlights (continued):

### Instructional Program Area *Baccalaureate/ Transfer*



**Baccalaureate/transfer** remained the largest credit instructional program area, **enrolling 4 out of 10** (40.4percent) community college students during fiscal

year 2010. Enrollments in transfer programs increased 7.3 percent compared to last year.

- Although 40.4 percent of the fiscal year 2010 credit student population was enrolled in the baccalaureate/transfer area, only 34.0 percent of all students indicated an intent to transfer.

### *Career & Technical Education*

Career and Technical Education credit program enrollments accounted for **more than one-quarter** of all credit students (28.2 percent). Enrollments in Career and Technical programs increased (+9.6 percent) from last year.



### *Largest Career & Technical Education Programs*

The largest CTE curricula during fiscal year 2010 included: Associate Degree in Nursing\Registered Nursing (N = 17,522), Child Care Provider (N = 6,655), Criminal Justice Technology (N = 6,541), Certified Nursing Assistant (N = 5,285), and Business Administration and Management (N = 4,653). RN program enrollments represent individuals who are pursuing the program but are not limited to individuals who have been formally admitted to the program.

### *Adult Education*

Students enrolled in **adult education** courses in community colleges accounted for **14.5 percent** of the credit generating students. Enrollment in adult education decreased by 4.0 percent compared to fiscal year 2009.

- **Over half** (53.9 percent) of students enrolled in adult education were taking **English as a Second Language (ESL) courses**.

### *Enrollment Hours by Term & Type of Attendance*

- **About two-out-of-three credit students attended on a part-time basis** during both the fall (64.7 percent) and spring (67.2 percent) semesters in fiscal year 2010.

### *Highest Degree Previously Earned*

- Nearly 19 percent of the credit-generating students are known to already have earned some type of college certificate or degree. This includes **36,008** who **earned Bachelors' degrees or higher**.

There are 48 public community colleges located throughout the state. In addition to their main campuses, colleges have branch campuses, extension centers, and outreach locations throughout their service regions.

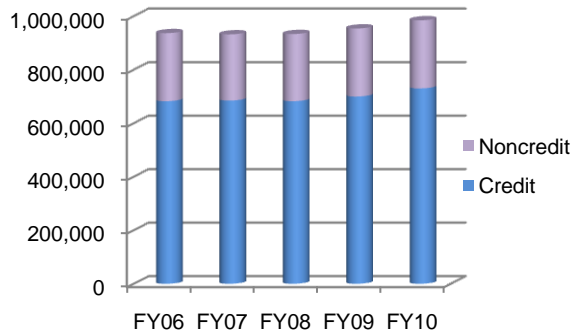

This year's report is based on fiscal year 2010 enrollments and completions (A1). Comparative information is supplied from four previous fiscal years (2006-2009). Detailed tables comparing fiscal year 2009 and fiscal year 2010 credit headcount, full-time equivalent (FTE) enrollments, and graduates by college are included. FTE enrollments in this report are based on all credit hours attempted (reimbursable and non-reimbursable credits).

**Annual Report Highlights:**

- In fiscal year 2010, nearly **one million (985,010) students** enrolled in credit and noncredit courses at Illinois Community Colleges. Combined enrollments increased compared to last year (+3.2 percent, N = +30,614).
- **Credit-generating** students accounted for **nearly three-quarters** (74.1 percent) of FY 2010 headcount enrollments.
- During fiscal year 2010, the 48 public community colleges in Illinois enrolled **730,335** students in credit generating courses. This is an increase over last year (N = +30,263). The full-time equivalent (FTE) enrollment was 273,344, an increase of 9.2 percent since fiscal year 2009.
- Statewide, just 3.4 percent (N = 33,428 of 985,010) of the students enrolled in both credit and noncredit courses during fiscal year 2010 (A1 and N1). These data show that **credit and noncredit courses are meeting largely different student and community needs.**



**Male/Female Distribution**

- Females comprised 54.7 percent of the fiscal year 2010 student population enrolled in credit-generating programs.

**Student Age**

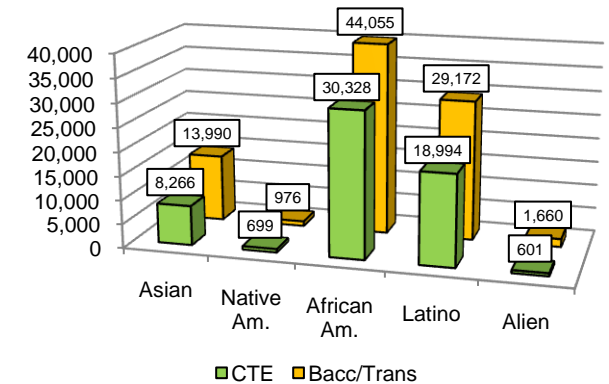
- The median age of credit-generating students was **25.4** during fiscal year 2010, a slight decrease from the previous year. The average age also decreased at **30.5** years.

**Ethnic Origin**

- **Minority (non-white) students accounted for over one-third** (37.0 percent) of the credit students enrolled. African American student representation increased (11.1 percent) and accounted for 15.6 percent of all credit students. Latino student representation decreased to 16.1 percent. Asian student participation increased slightly from the previous year to 4.5 percent, while foreign/ nonresident alien representation decreased to 0.4 percent.

**Attempted vs. Earned Credit Hours**

- Illinois community college students were enrolled in **8,200,327 credit hours** throughout fiscal year 2010 and earned **77.4 percent** of those hours.
