

#### Introduction

The Illinois Community College System meets both local and statewide needs for education and workforce development by providing high-quality, accessible, cost-effective educational opportunities, programs, and services for a diverse student population. The system provides traditional and nontraditional students with smooth transitions into and across higher education and training for in-demand occupations with economic value. Community colleges create an educated and skilled workforce by increasing credential attainment, building quality career pathways, closing the skills gap, and addressing the future needs of the workforce. During the pandemic, faced with unprecedented challenges, all 48 Illinois Community Colleges implemented campus measures to ensure a safe instructional environment employing substantial adjustments to instruction by moving many courses to remote or online modalities to aid with mitigation efforts.

According to the <u>National Center for Education Statistics</u>, postsecondary enrollments have been in decline nationally since 2009. Additionally, the impact of the pandemic on enrollment has been well-documented across the postsecondary landscape and every sector has been impacted. Community colleges, as open access institutions, serve a significant number of at-risk students. Illinois Community College System enrollment in the prior year is reflective of challenges stemming from the pandemic and consistent with national community college enrollment declines. In Illinois more recent data from the current academic year (Fall 2022 semester) reflects an increase in enrollment, reversing both state and national trends. The system is well-positioned to offer all students the services necessary to fulfill education and workforce training needs.

With 64,797 earned collegiate-level degrees and certificates, fiscal year 2022 had the seventh highest annual number of graduates ever recorded for the Illinois Community College System. As illustrated in Figure 1, the annual Illinois Community College System number of program graduates decreased six percent from fiscal year 2013 to 2022. During the same timeframe, enrollments decreased by forty-three percent statewide.

Under the authority of the P-20 Longitudinal Education Data System Act (105 ILCS 13/1 et seq.) (the "LDS Act"), ICCB is the State Education Authority responsible for collecting and maintaining enrollment, completion, and student characteristic information on community college students. The data within the Annual Enrollment and Completion Report derive from ICCB's Centralized Data System. Illinois Community Colleges submit Annual Enrollment (A1) microdata for individuals who are officially enrolled at the college in credit coursework at any time during the specified fiscal year. Beginning in fiscal year 2014, the Annual Completions (A2) submission is the microdata source of student completions. This year's Annual Enrollment and Completion Report is based on fiscal year 2022 enrollments and completions. Comparative information is supplied from four previous fiscal years (2018-2021). Detailed tables comparing fiscal year 2021 and fiscal year 2022 credit headcount, full-time equivalent (FTE) enrollments, and graduates by college are included. FTE enrollments in this report are based on all credit hours attempted. Thirty credit hours equal one FTE.

Also included in the Annual Enrollment and Completion Report is information about noncredit offerings for the current year (2022) and the four previous fiscal years (2018-2021). Noncredit courses provide another delivery method of education, training, and public service by community colleges to the communities they serve. Since fiscal year 1999, the Illinois community colleges have submitted Noncredit Enrollment (N1) annual microdata for students containing demographic and course information on the wide range of noncredit instruction.

## **HIGHLIGHTS OF FISCAL YEAR 2022 ANNUAL REPORT**

## **Student Enrollments**

- The Illinois Community College System served 503,579 students in credit and noncredit courses during fiscal year 2022. Overall combined enrollments increased compared to last year (1.6 percent, N = 7,791).
- Credit-generating students accounted for 78.8 percent of the overall fiscal year 2022 headcount.
- During fiscal year 2022, the 48 public community colleges in Illinois enrolled 396,958 students in instructional credit courses. This is lower than the previous year (405,444). The full-time equivalent (FTE) enrollment was 154,608, a decrease of 4.1 percent since fiscal year 2021.
- Statewide, 10,697 of 503,579 total students enrolled in both credit and noncredit courses during fiscal year 2022 (A1 and N1). While there is some overlap, these data suggest that credit and noncredit courses are meeting largely different student and community needs.
- Females comprised 56.1 percent of the fiscal year 2022 student population enrolled in credit-generating programs.
- Minority (non-white) students accounted for nearly half (48.7 percent) of the credit students enrolled. African American student representation increased (0.7 percent) and accounted for 12.6 percent of all credit students. Latino student representation increased (4.0 percent) and accounted for 26.4 percent of all credit students. Asian (5.5 percent) and Two or More Races (3.0 percent) student representation decreased from the previous year, while Nonresident (0.9 percent) student representation increased.
- Six in ten Pell recipients were minority (non-white) students in fiscal year 2022 (61.5 percent).
- Forty percent of students in fiscal year 2022 were first-generation students (39.5 percent).
- The median age of credit-generating students was 21.7 during fiscal year 2022, a slight decrease from the previous year. The average age was unchanged from the previous year at 26.4 years in fiscal year 2022.
- Transfer remained the largest credit instructional program area enrolling 55.9 percent of fiscal year 2022 Illinois Community College System students. Enrollments in Transfer programs decreased 4.3 percent compared to the previous year.

- Statewide, Career and Technical Education credit program enrollments accounted for one-quarter of all credit students (25.2 percent). Enrollments in Career and Technical Education programs increased 1.3 percent from last year.
- Students enrolled in Adult Education courses in community colleges comprised 9.1 percent of the credit-generating students. Enrollments in Adult Education increased by 13.9 percent versus fiscal year 2021.
- Of the students in Adult Education, 49.6 percent were enrolled in English as a Second Language (ESL) courses.
- Although 55.9 percent of the fiscal year 2022 credit student population was enrolled in the Transfer area, only 39.7 percent of all students indicated intent to transfer.
- One-half (47.2 percent) of the fiscal year 2022 credit students enrolled in the colleges
  indicated that they were not pursuing a degree, but attending to complete one or
  several courses. Participation in college to take courses instead of pursuing a degree
  or certificate remained similar compared to the previous year.
- More than two out of three credit students attended on a part-time basis during both the fall (68.8 percent) and spring (73.7 percent) semesters in fiscal year 2022.
- Twenty-one percent of the credit-generating students are known to already have earned some type of college certificate or degree. This includes 17,137 who earned a bachelor's degree or higher.
- Illinois community college students enrolled in 4,638,244 credit hours throughout fiscal year 2022 and earned 79.2 percent of those hours.
- Accumulated credit hours were available for 83.6 percent of the fiscal year 2022 student population. More than one-third of them (37.4 percent) attained sophomore-level status by accumulating 30 or more college-level hours.
- Cumulative grade point average data was reported for 81.9 percent of the fiscal year 2022 students. One-half (54.0 percent) held an A-B average.
- In fiscal year 2022, one in ten (10.1 percent) Illinois community college students (not enrolled in ABE/ASE/ESL, Vocational Skills, or General Studies) were enrolled in at least one developmental course—a decrease from fiscal year 2021.
- In fiscal year 2022, Illinois community college students earned 64.3 percent of the developmental credits they attempted. This percentage is down slightly from 66.5 percent in fiscal year 2021.

- Fiscal year 2022 unduplicated noncredit headcount increased 18.0 percent over last year to 106,621 students. The duplicated headcount or "seatcount" was 21.1 percent higher than the previous year.
- Statewide, 13,670 noncredit course sections were conducted during fiscal year 2022.
- Female students accounted for 53.4 percent of 2022 noncredit enrollments for which gender data were reported.
- Minority students accounted for nearly one-third (31.5 percent) of the individuals enrolled in noncredit courses who supplied racial/ethnic data.
- The median age of noncredit students was 34.4 during fiscal year 2022. The average age was 38.5 years.
- Over two-fifths (41.7 percent) of the noncredit students were 40 years of age or above among the individuals who supplied this information.
- Nearly two-thirds of the noncredit offerings (duplicated) were in the Personal and Social Development category of activity. Over one-fourth of the noncredit coursework were dedicated to developing workplace skills: Professional/Vocational (18.7 percent) and Business and Industry Contractual training (8.7 percent).
- Across all categories of activity, six broad course enrollments (two-digit CIP) had over 5,000 noncredit students enrolled. These six areas accounted for nearly two-thirds of the students enrolled in noncredit courses with CIP data (65.5 percent). Approximately two out of five enrollments in these large CIPs were in work-related courses: Health Professions (13.9 percent), Business Management (12.7 percent), Transportation (10.1 percent), and Security and Protective Services (6.5 percent).
- Noncredit enrollments by term were 42.1 percent in Spring, 32.7 percent in Fall, and 25.2 percent in Summer in fiscal year 2022.
- Over two-fifths of the 2022 noncredit courses were held on main college campuses (42.0 percent) and one-fifth were held via distance education (20.4 percent).

## **Student Completions**

- A total of 64,797 collegiate-level degrees and certificates were awarded to Illinois community college students in fiscal year 2022.
- The number of community college completions in fiscal year 2022 is the seventh highest count ever reported.

- The number of degrees and certificates awarded increased 4.9 percent from fiscal year 2021 (+3,014 completers). Taking a longer view-compared to fiscal year 2018—the total number of fiscal year 2022 completions increased 0.2 percent.
- Career and Technical Education accounted for the largest number of graduates (N = 35,981) in fiscal year 2022. Just over half of the earned degrees and certificates were in Career and Technical Education programs during fiscal year 2022 (55.5 percent). Career completions increased 11.4 percent from last year.
- Transfer completions accounted for the second largest group of completers in fiscal year 2022 (N = 26,106). Four out of ten graduates earned Transfer completions (40.3 percent). The number of Transfer completions decreased 3.2 percent (-863) from last year. Nearly three out of ten Transfer graduates earned the General Education Core Curriculum Credential.
- Twenty-six percent of the Career and Technical Education awards in fiscal year 2022 were AAS degrees.
- Females accounted for 56.0 percent of all 2022 completions.
- Career and Technical Education Certificates of Nine to less than Thirty Semester Hours accounted for the largest number of male completers (N = 7,525), and Associate in Arts accounted for the largest number of female completers (N = 8,151) of a specific degree or certificate.
- Although small in number, the Associate in Engineering Science (N = 349) had the highest proportion of male graduates (81.7 percent, N = 285).
- Minority students earned 41.0 percent of the collegiate-level degrees and certificates awarded in the Illinois Community College System during fiscal year 2022. Latino students earned 22.3 percent, African American students earned 10.3 percent, and Asian students earned 4.4 percent of all degrees and certificates.
- Minorities accounted for 42.7 percent of total Transfer degree and certificate recipients.
- More minority graduates completed Career and Technical Education degrees and certificates (N = 14,127) than Transfer degrees and certificates (N = 11,139).
- Among the largest minority groups, Latino (N = 14,460) students completed more than twice as many collegiate-level awards than African American students (N = 6,700).

- Twenty-five percent of the students who were awarded degrees and certificates during fiscal year 2022 were less than 21 years of age. The other age groups with the largest percentages of graduates were 21 to 24 (35.3 percent), 25 to 30 (17.0 percent), 31 to 39 years of age (12.3 percent), and 40 to 55 years of age (8.4 percent).
- Seven out of ten Transfer degree and certificate completers in 2022 indicated intent to transfer to a four-year institution.
- Approximately 17.0 percent of fiscal year 2022 Associate in Applied Science degree graduates indicated goals to complete some courses or finish a certificate.

## **OVERALL FISCAL YEAR 2022 STUDENT ENROLLMENTS**

The Illinois Community College System had 503,579 students in credit and noncredit courses during fiscal year 2022. Overall combined enrollments increased compared to last year (1.6 percent, N = 7,791).

Table 1 provides a summary comparison of fiscal year 2018 through fiscal year 2022 credit and noncredit unduplicated enrollments. Total enrollments reflect those students who may be concurrently enrolled in credit-generating and noncredit courses during the fiscal year.

Detailed comparisons of fiscal year 2018 through fiscal year 2022 unduplicated credit and noncredit headcount enrollments for each community college are provided in Appendix tables A-1 and B-1, respectively.

As depicted in Figure 2, credit-generating students account for 78.8 percent of the overall fiscal year 2022 headcount. Enrollments had been growing prior to fiscal year 2010, but they have decreased each year since then. Fiscal year 2022 credit-generating enrollments are the lowest of the most recent five years. Noncredit enrollments are the fourth lowest of the most recent five years.

Statewide, 10,697 of 503,579 total enrolled in both credit and noncredit courses during fiscal year 2022 (A1 and N1). While there is some minimal overlap (2.1 percent), credit and noncredit courses are meeting largely different student and community needs.

## FISCAL YEAR 2022 STUDENT CREDIT ENROLLMENTS

## **Student Credit Enrollment by Community College**

Annual credit enrollment for fiscal year 2022 was 396,958, and full-time equivalent (FTE) students totaled 154,608. Table 2 contains comparative enrollment data for the last five years. Fiscal year 2022 saw a decrease of 2.1 percent in credit headcount enrollment from the previous year. Fiscal year 2022 FTE enrollment decreased by 4.1 percent compared to last year. Compared to five years ago, fiscal year 2022 credit headcount enrollments decreased by 23.6 percent. FTE enrollments decreased 22.4 percent since 2018. Historically, for the sixth straight year credit headcount enrollments in fiscal year 2022 were at the lowest level since annual headcount enrollments were collected beginning in 1979 (N = 562,213).

Table A-1 in the Appendix provides a comparison of fiscal year 2018 through fiscal year 2022 headcount enrollments for each community college. Among Illinois' 48 community colleges, 16 colleges reported an increase in headcount, while 27 exhibited decreases compared to fiscal year 2021. Five colleges experienced little or no change (1.0 percent or less) during fiscal year 2022. Table A-2 contains a comparison of full-time equivalent (FTE) enrollments for fiscal years 2018 through 2022. FTE calculations convert the substantial part-time enrollment into the number of students there would be if everyone attended on a full-time basis. Over the last year, only nine colleges experienced an increase in FTE, 32 reported decreases, and seven colleges experienced little or no FTE change versus fiscal year 2021.

## **Male/Female Distribution**

The male/female distribution of credit students typically fluctuates little from year to year with female students consistently constituting a slight majority. Females comprised 56.1

percent of the student population in fiscal year 2022. The percentage of male students averaged 44.9 percent over the past five years (see Table A-3).

## **Ethnic Origin**

In fiscal year 2022, nearly half (48.7 percent) of those participating in credit coursework in community colleges were minority (non-white) students (among those whose ethnicity was known). Race/ethnicity classifications are aligned with U.S. Department of Education collection and reporting standards. The number of minority students increased 2.1 percent from fiscal year 2021 to fiscal year 2022, and the proportion of minority students increased slightly from 46.7 percent last year to 48.7 percent in fiscal year 2022. During the past five years, students from minority groups comprised an average of nearly five in ten (47.0 percent) of the student population. Latino students (now numbering 100,600) became the largest minority group in 2000, and have been each year since, except in fiscal year 2012, when African American students (now numbering 47,952) were the largest minority group. Compared to last year, an increase was noted in credit headcount enrollments among both African American students and Latino students. In fiscal year 2022, the number of Latino credit students enrolled increased by 4.0 percent, and the number of African American students enrolled in Illinois community college credit courses increased by 0.7 percent (see Table A-4a).

Overall, 73,139 students participating in credit coursework received Pell grants in fiscal year 2022. Pell recipients include students who were awarded a Pell grant and dollars were disbursed. In addition, Pell recipients include recipients in Dual Enrollment and Second Chance Pell experiments at federally approved experimental sites. The number of Pell recipients decreased 3.3 percent from last year and decreased 25.5 percent from fiscal year 2018. Six in ten Pell recipients (61.5 percent) were minority (non-white) students (among those whose ethnicity was known). The number of minority students receiving Pell grants decreased 1.0 percent from fiscal year 2021, while the proportion of minority students increased slightly from 60.0 percent last year to 61.5 percent in fiscal year 2022. During the past five years, students from minority groups comprised an average of six in ten (60.1 percent) students who received Pell grants. Latino students were the minority group with the largest number of Pell recipients (30.9 percent), followed by African American students (21.1 percent), Asian students (5.0 percent), and students of Two or More Races (3.9 percent). Compared to last year, decreases were noted in all race/ethnicity classifications except Latino students who saw a slight increase (+1.8 percent) (see Table A-4b).

Forty percent of students in credit coursework in fiscal year 2022 were first-generation students (39.5 percent). The number of first-generation students decreased 0.5 percent from last year and decreased 24.5 percent from fiscal year 2018. Minority (non-white) students (among those whose ethnicity was known) accounted for nearly six in ten (58.2 percent) first-generation students. The number of minority first-generation students decreased slightly (-5; 0.0 percent) from fiscal year 2021, but the proportion of minority first-generation students increased from 57.7 percent last year to 58.2 percent in fiscal year 2022. During the past five years, while the number of first-generation students from

minority groups decreased each year, the proportion of minority first-generation students increased slightly each year. Among the minority groups of first-generation students, Latino students were the largest (37.7 percent) followed by African American students (13.5 percent), Asian students (3.6 percent), and students of Two or More Races (2.4 percent). Compared to last year, an increase was noted in first-generation student headcount among Native American students (12.4 percent), Nonresident students (1.4 percent), and Latino students (0.8 percent) (see Table A-4c).

## **Student Age**




Figure 3. Age Distribution of Credit Students, FY 2022

In fiscal year 2022, the average age of Illinois community college students in credit courses was 26.4 years which is unchanged from fiscal year 2021 (26.4 years). The median age was 21.7 years, which is lower than last year (21.9 years). Available age data are depicted in Figure 3. The largest proportion of students (39.1 percent) was ages 17 through 20 and saw a decrease of 0.5 percent over fiscal year 2021. The second largest proportion of students (21.3 percent) was ages 21 through 24 and had a decrease of 6.0 percent over fiscal year 2021. The third largest proportion of students (12.1 percent) was 25 through 30 years of age with a decrease of 8.4 percent over fiscal year 2021. During fiscal year 2022, 10.5 percent of students was age 31 through 39, 9.3 percent was age 40 through 55, and 3.1 percent of students was over 55. Usually the smallest in size, the 16 and under age group was the second smallest in fiscal year 2022, representing 4.6 percent of the student population and increasing 21.3 percent from last year. Dual credit and dual enrollment arrangements where high achieving high school students are allowed to enroll in college-level courses are contributing to enrollment among the younger student populations (see Table A-5).

## Summary of Enrollments by Instructional Program Area

Short-term, fiscal year 2022 enrollment decreased in three of the instructional program areas: 4.3 percent in Transfer, 5.6 percent in General Associate, and 16.1 percent in Vocational Skills. Adult Education [Adult Basic Education (ABE) and Adult Secondary Education (ASE)] and English as a Second Language (13.9 percent), General Studies Certificate (12.1 percent), and Career and Technical Education (1.3 percent) increased from fiscal year 2021. Longer term, between fiscal years 2018 and 2022, decreases were seen in all of the instructional program areas—General Associate, Vocational Skills, Transfer, Career and Technical Education, General Studies Certificate, and Adult Education including English as a Second Language (ESL).

**Transfer** was the largest instructional program offered in the Illinois Community College System accounting for nearly six out every ten credit students. This program is designed to provide individuals with the equivalent of the initial two years of a bachelor's degree. Statewide, enrollment in this program area decreased over the past year (-4.3 percent) and was down 16.5 percent between fiscal years 2018 and 2022.

**Career and Technical Education** programs were the second largest credit program in the Illinois Community College System, accounting for one-quarter of all credit enrollments. Career and Technical Education enrollments increased 1.3 percent compared to last year and were down 23.7 percent since 2018. Between fiscal years 2018 and 2022, enrollment in **General Studies Certificates** programs decreased by 59.7 percent, enrollment in **Vocational Skills** programs decreased by 56.1 percent, and enrollment in **General Associate Degree** programs decreased by 20.6 percent, (see Table A-6a).

Students enrolled in community college **Adult Education** (ABE, ASE, and ESL) courses comprised 9.1 percent of the credit generating students in fiscal year 2022. Hence, about one out of eleven community college students was enrolled in Adult Education skills building coursework. Statewide, there was a 13.9 percent increase in Adult Education enrollments over the previous year, and community college Adult Education enrollments were down 36.3 percent since fiscal year 2018. In fiscal year 2022, 49.6 percent of the students in Adult Education was enrolled in English as a Second Language (ESL) courses.

The City Colleges of Chicago accounted for more than two-third (34.3 percent) of statewide community college Adult Education enrollments in fiscal year 2022. Adult Education enrollment at the City Colleges of Chicago decreased 6.8 percent over last year compared to the decrease in overall enrollment of 6.5 percent at the City Colleges of Chicago. Excluding the City Colleges of Chicago, there was a 28.9 percent increase in Adult Education enrollment in fiscal year 2022 compared to last year (see Table A-6a and A-6b).

Longer term, excluding the City Colleges of Chicago, the rest of the system experienced an overall decrease in enrollments (-22.3 percent) between 2018 and 2022. Looking back

across five years, analysis of instructional program area information and excluding City Colleges of Chicago data showed mostly similar declines for the rest of the system. The small General Studies Certificate programs recorded a 59.7 percent decline excluding the City Colleges of Chicago; General Associate programs were down 14.9 percent excluding City Colleges of Chicago. Decreases were also exhibited in Transfer (-15.3 percent), Career and Technical Education (-24.3 percent), and Vocational Skills (-56.1 percent) program enrollments between fiscal years 2018 and 2022 without the City Colleges. Long-term results in Adult Education were also down significantly across the rest of the system (-28.1 percent) (see Table A-6b).

#### Instructional Program Enrollments by Gender

During fiscal year 2022, females outnumbered males in nearly all instructional areas; only Career and Technical Education programs contained a higher proportion of male students (51.1 percent). The highest proportion of female students was enrolled in General Associate degree programs (68.1 percent), followed by English as a Second Language programs (67.9 percent), and Adult Education (ABE and ASE) programs (63.3 percent). Transfer programs consisted of 57.0 percent female students, 56.7 percent of those enrolled in General Studies Certificate programs were female, while 51.2 percent of Vocational Skills enrollment was female (see Table A-7).

## Instructional Program Enrollments by Racial/Ethnic Origin

Figure 4 illustrates the distribution of minorities in the two largest program areas, Transfer and Career and Technical Education. An examination of each racial/ethnic group's representation across program areas in fiscal year 2022 indicated that the largest percentage of students in each racial/ethnic group was enrolled in Transfer programs: Two or More Races (66.2 percent), Asian (64.0 percent), White (57.9 percent), Native American (55.5 percent), Nonresident (54.0 percent), Pacific Islander (53.6 percent), Latino (51.7 percent), and African American (53.7 percent). Latino students were enrolled in a larger proportion of Transfer (51.7 percent) than English as a Second Language (11.6 percent) programs. Overall, minority students (nonwhite including unknown) were least represented in the General Studies Certificate (27.0 percent), Vocational Skills (32.5 percent), Career and Technical Education (44.7 percent), and Transfer (49.0 percent) areas (see Table A-8).

#### <u>Instructional Program Enrollments by Age</u>

During fiscal year 2022, two-thirds of community college credit students was under 25 years of age (65.0 percent). Two-thirds of the students under 25 enrolled in Transfer programs (69.5 percent). One out of every four (22.6 percent) credit students was between 25 and 39 years of age. Two program areas account for the largest portion of students between 25 and 39 years of age: Transfer (35.7 percent) and Career and Technical Education (34.8 percent). Overall, about one in eight Illinois community college credit students was at least 40 years of age (12.3 percent). Among students 40 years of age and above, most were primarily enrolled in workforce related courses (49.8 percent) which includes Career and Technical Education (34.6 percent) and short-term intensive Vocational Skills (15.2 percent) courses. One in five students aged 40 and above was pursuing a transfer program (21.0 percent) (see Table A-9).

#### Largest Career and Technical Education Programs

The largest Career and Technical Education curricula in fiscal year 2022 included Engineering Technologies; Associate Degree in Nursing; Business, Management, Marketing, and Related Supportive Services, Other; Business Administration and Management; and Nursing Assistant/Aide and Patient Care Assistant/Aide. Only two of these programs decreased in enrollment compared to the previous year. Engineering Technologies was again the largest program in fiscal year 2022, with 10,733 enrollments but saw an increase of 14.8 percent (+1,386 students) from fiscal year 2021. With 7,867 students in fiscal year 2022, Associate Degree Nursing/Registered Nursing (ADN/RN) was the second largest program, and enrollment decreased by 10.6 percent (-928 students) over last year. ADN/RN program enrollments represent individuals who are

pursuing the program but are not limited to individuals who have been formally admitted to the program. The third largest program (Business, Management, Marketing, and Related Supportive Services, Other) increased over the previous year (+6.5 percent; +430 students). Business Administration and Management decreased 6.2 percent (-233 students) and was the fourth largest program in fiscal year 2022. Nursing Assistant was the fifth largest program and increased 5.3 percent (+172 students) in fiscal year 2022 (see Table A-10).

#### Instructional Program Enrollments by Intent

Intent data provide the primary goals that students plan to achieve as a result of their studies. Initial intent data are self-reported by students when they first enroll at the college. College staff is asked to require each student to update goal information each semester and provide a current intent, as well as to retain the student's original entry intent. One in four students reported a workforce goal, which includes preparing for a job immediately after community college program completion (18.3 percent) and improving skills for a current position (8.7 percent). More students reported a goal of preparing for transfer to a four-year institution (39.7 percent). High school equivalency preparation was the goal for 8.0 percent of the students.

In an examination of student intent by program area, over one-half of the students in Adult Education (ABE and ASE), English as a Second Language, Career and Technical Education, Transfer, and Vocational Skills programs reported the goal that is most often associated with a given major. About three-quarters of the ABE/ASE and ESL students listed a desire to remedy basic skills deficiencies or to prepare for the high school equivalency test as their reason for enrolling in these programs. Fifty-seven percent of students in Career and Technical Education programs enrolled with the intent of preparing for a job after community college or improving their job skills for their current position. Fifty-six percent of the students enrolled in Transfer programs indicated the intent to transfer to a four-year institution. Fifty-five percent of the Vocational students enrolled with the intent of preparing for a job after community college or improving job skills for their present position (see Table A-11).

## <u> Instructional Program Enrollments by Degree Objective</u>




Figure 5. Degree Objective for Transfer and Career and Technical Education, FY 2022

Degree objective data are also self-reported and are designed to assist colleges in classifying students by curriculum or course enrollee category. The objectives convey the students' expected outcomes from attending the community college. In fiscal year 2022, 47.2 percent of all students indicated that they were enrolling with no intention of pursuing a degree—only to complete one or several courses. Figure 5 contains information on degree objective for the two largest community college programs. Transfer students were split between degree-seekers (51.3 percent) and course takers (46.7 percent). A small contingent of students in Transfer programs indicated an interest in completing a certificate, which would entail changing to a career or general studies major. Half (49.7 percent) of the Career and Technical Education students indicated they expected to complete an Associate degree, while 28.4 percent expected to complete one or several courses. One in five planned to complete a certificate. Many Career and Technical

students planned to complete an entire program, while others simply wanted to improve their current skills or obtain new skills to enter a different career. At least nine out of ten students in the following program areas planned to only complete one or several courses: Vocational Skills, ABE/ASE, and English as a Second Language (97.1; 94.6; and 94.2 percent, respectively) (see Table A-12).

## **Enrollment Hours by Term and Type of Attendance**

Part-time attendance is prevalent among community college students who are often simultaneously engaged with college coursework, careers, and family responsibilities. During the fall semester, two-thirds (68.8 percent) of the students attended on a part-time basis (less than 12 credit hours). The part-time proportion was slightly higher (73.7 percent) in the spring. In a pattern not typical among higher education institutions, Illinois community college enrollment during the spring semester (256,870) is usually slightly higher than in the fall (252,408). Enrollment was higher for part-time in spring (189,366) than in fall (173,775), but not for full-time (spring = 67,504 and fall = 78,633). Nine out of ten students (88.9 percent) attended on a part-time basis during the summer term of fiscal year 2022 (less than nine credit hours) (see Table A-13).

# Highest Degree Earned by Students Prior to Attending Community College




Figure 6. Headcount Enrollment by Prior Highest Degree Earned, FY 2022

The prior earned degree data reiterate that community colleges serve diverse populations. Figure 6 illustrates the educational background of fiscal year 2022 students. Prior degree reporting was similar compared to last year with less than two-thirds of the students providing this information (adult education students would typically not possess earned degrees). Nearly six in ten students entered the community college with a high school diploma/equivalency. Twenty-one percent earned some type of postsecondary certificate or degree. About 15 percent had already earned degrees at or beyond the community

college level. Nineteen percent of the students had previously taken college coursework without completing a certificate or degree (see Table A-14).

## **Attempted vs. Earned Credit Hours**

At all colleges and universities, there are students who, for a variety of reasons, are unable or unwilling to complete the requirements for the class(es) in which they enroll. In fiscal year 2022, Illinois community college students completed over 3.6 million credit hours, which was 79.2 percent of the hours they attempted. Full-time and part-time students earned a similar percentage of the hours they attempted (see Table A-15).

## **Accumulated College-Level Credit Hours**

Of the 331,967 students (83.6 percent) for whom data were available, nearly two-thirds (62.6 percent) accumulated less than 30 college-level hours (freshman level). Nearly one-fourth (21.7 percent) accumulated between 30 and 59 credit hours (sophomore status), and 15.7 percent earned 60 or more credit hours (see Table A-16).

## **Grade Point Averages**

Cumulative grade point average (GPA) data were available for 81.9 percent of the students enrolled in fiscal year 2022. Pre-college coursework does not generate GPA information. More than four out of five students had grade point averages of 2.01 or higher, which is a "C" average or above (86.0 percent). One-half of the students (54.0 percent) achieved

grade point averages in the "B" to "A" range (3.01 to 4.00). One-third (32.0 percent) achieved grade point averages in the "C" to "B" range (2.01 to 3.00) (see Table A-17).

## **Developmental Enrollment**

During fiscal year 2022, one in ten (10.1 percent) students enrolled in Illinois community colleges—not enrolled in ABE/ASE/ESL, Vocational Skills or General Studies—took at least one developmental course (34,757). This represented a decrease of 10.4 percent (-4,037) students since last year when there were 38,794 students enrolled in developmental courses. Over the most recent five-year period (2018-2022), the number of students enrolled in at least one developmental course decreased 45.8 percent (see Table A-19).

Nationally in 2015-16, 52.5 percent of first-year students at public 2-year institutions had ever enrolled in a remedial course, and 25.3 percent of these students were enrolled in remedial course(s) in fiscal year 2016. Nearly one in five were enrolled in remedial mathematics courses (18.6 percent). About one in ten was enrolled in remedial reading or writing (10.8 percent) courses (National Center for Education Statistics, 2020).

The appendices provide additional information on the academic area(s) in which students enrolled in developmental coursework at Illinois community colleges for fiscal years 2018 through 2022 (see Table A-21). Generally, community college students enrolled in developmental courses required assistance in only one academic area. Most of the time, the area was Mathematics. In fiscal year 2022, nearly six out of every ten students participating in developmental coursework needed assistance in just Math (54.4 percent). Compared to last year, Math Only developmental enrollments decreased 15.0 percent. Since fiscal year 2018, there was a decrease of 49.8 percent among students with the need to take developmental Math exclusively. In fiscal year 2022, English Only comprised 23.7 percent of the population requiring developmental assistance. About 2.9 percent of the developmental course enrollments was in Reading Only. Reading difficulties are particularly problematic since they impede an individual's ability to acquire new knowledge through written documents, which is a foundational skill in every academic course. Additionally, 2.4 percent of the fiscal year 2022 students who enrolled in developmental coursework took both English and Reading courses. Combinations of Math, English, and Reading developmental needs showed that seven in ten (70.9 percent) community college students who enrolled in developmental courses required assistance with their Math skills-alone or in combination with other areas. From fiscal years 2021 to 2022, the proportion of students requiring help in Math-either alone or in combination with other areas-saw a slight decrease (73.3 percent last year). Long term, the proportion of students requiring Math skills enhancement-either alone or combined with other areas-also saw a decrease (79.3 percent in fiscal year 2018). Two percent of the students in developmental courses (N = 749) needed assistance in all three areas-Math, English, and Reading. Requiring assistance in all three areas is a particularly serious situation since weaknesses exist across the spectrum of skills required to acquire and process new information.

Overall during fiscal year 2022, Illinois Community College System students earned nearly two-thirds (64.3 percent) of the developmental credits they attempted. This was a slight decrease from fiscal year 2021 when students earned 66.5 percent of the developmental credits attempted. Looking at the five-year period of 2018 to 2022, the percentage of developmental credits earned has remained steady around two-thirds each year (see Table A-20).

# FISCAL YEAR 2022 STUDENT NONCREDIT COURSE ENROLLMENT

# Student Noncredit Course Enrollment by Community College

Illinois community colleges provide a wide range of noncredit instruction to meet a variety of community needs. Table 3 contains comparative noncredit enrollment data for the last five years. Fiscal year 1994 was the first year in which annual noncredit course enrollment data were collected. Beginning in fiscal year 2002, data are from the Noncredit Course Enrollment database (N1) which includes individual records for each student. Fiscal year 2022 is the twenty-fourth year that the Illinois Community College System has undertaken data collection through a noncredit course enrollment database (N1).

The number of noncredit course offerings and enrollments at the community colleges often varies from year to year, depending on the needs of the surrounding communities. Comparisons of fiscal years 2018 through fiscal year 2022 noncredit headcount enrollments and course sections conducted for each community college are provided in Appendix Tables B-1, B-2, and B-3. Reasons for the recent declines in noncredit activity and participation vary by locality. Local community college budgets continue to be tight and, generally, noncredit courses are only offered if they break even or are profitable. Additionally, there has been some resurgent resistance to reporting individual participant data. Records are not added to the noncredit database unless the category of activity

information is supplied—business/industry contract; professional/vocational development; personal/social development; and youth programs.




Figure 7. Noncredit Course Enrollments, FY 2018-2022

During fiscal year 2022, Illinois community colleges conducted 13,670 noncredit course sections, 32.4 percent more than the previous year. From fiscal years 2018 to fiscal year 2022, the total number of course sections offered through the colleges decreased 28.9 percent. Despite a decrease in course offerings over the past five years, noncredit offerings continue to be an important part of college efforts to meet community and employer needs. Figure 7 illustrates that unduplicated student enrollments decreased from fiscal year 2018 to fiscal year 2022. During fiscal year 2022, the unduplicated noncredit headcount (in which students are counted only once, regardless of the number of noncredit courses in which they enroll) increased 18.0 percent from the previous year. Over a longer time frame, unduplicated noncredit headcounts have decreased 37.2 percent over the last five fiscal years. The duplicated headcount (also known as "seatcount") during fiscal year 2022 was 21.1 percent higher than the previous fiscal year and 40.2 percent lower than five years earlier.

## **Characteristics of Noncredit Students**

Information is available to provide additional detail about the characteristics of the students enrolled in noncredit coursework at community colleges in fiscal year 2022. Still, there tends to be more unknown/unreported information in the noncredit data than in the credit submission. Cited percentages among noncredit enrollments are based on the reported data. Student characteristic information is based on unduplicated counts.

Information pertaining to course offerings is based on duplicated counts, since course attributes change and individuals can and do enroll in multiple courses.

#### Noncredit Student Gender

Similar to the distribution for credit programs, female students accounted for 53.4 percent of 2022 noncredit enrollments for which gender data were reported. Approximately 2.7 percent of students did not provide gender data. Gender data by category of activity show that most missing gender information was among individuals enrolled in business and industry contract courses (see Table B-4).

#### Noncredit Student Ethnic Origin

Racial/ethnic reporting among noncredit students was less complete than among credit students, as more than two-fifths (44.0 percent) of noncredit records were missing racial/ethnic data. Minority students accounted for nearly one-third (31.5 percent) of the individuals enrolled in noncredit programs who supplied racial/ethnic information. In credit programs during the past five years, minorities accounted for an average of 47.0 percent of the student population. Available noncredit data indicated the following racial/ethnic distribution: White (68.5 percent), Latino (13.2 percent), African American (10.8 percent), Asian (5.1 percent), Two or More Races (1.4 percent), Nonresident (0.4 percent), Native American (0.4 percent), and Pacific Islander (0.2 percent) (see Table B-5).

## Noncredit Student Age




Figure 8. Age Distribution of Noncredit Students, FY 2022

Based on available data, the average age of students enrolled in noncredit coursework during fiscal year 2022 was 38.5 years, and the median age was 34.4 years. Age information was missing for one-fourth (24.0 percent) of noncredit students during 2022. Noncredit programming served a more mature clientele than credit courses. Available age data are depicted in Figure 8. Over two-fifths (41.7 percent) of noncredit students were 40 years of age or older. One-fifth (20.5 percent) of noncredit students was ages 40 to 55, and one-fourth (24.8 percent) was between 25 and 39 years of age. One-third (33.5 percent) of noncredit students was under 25 years of age (see Table B-6).

## **Noncredit Category of Activity (Duplicated)**




Figure 9. Category of Activity, Noncredit Course Enrollments (Duplicated), FY 2022

For state reporting purposes, noncredit coursework is grouped into four broad categories: Business and Industry Contract, Professional/Vocational Development, Personal and Social Development, and Youth Programs. Records were not added to the database unless the category of activity information was supplied. Duplicated noncredit enrollment counts are used in the category of activity information depicted in Figure 9 (also see Table B-11).

Based on a duplicated count, 60.7 percent of the noncredit offerings were in the Personal and Social Development category. Personal and Social Development programming is an important community service provided by the colleges. Typically, these courses are offered as long as demand is sufficient to at least cover the cost of course delivery. They can also serve as a gateway to other credit or workforce-oriented courses offered by the college. Over one-fourth (27.4 percent) of the noncredit coursework were dedicated to developing workplace skills: Professional/Vocational (18.7 percent) and Business and Industry Contractual Training (8.7 percent). These courses meet the needs of area residents who are interested in acquiring specific skills without earning academic credit. Providing customized training is an important economic development activity in which colleges collaborate with local employers to tailor content and instructional delivery to their specific requirements. Illinois community colleges are extensively relied upon to develop and deliver coursework addressing the unique training requirements of area businesses, industries, and governmental organizations. The remaining 11.9 percent helped serve the needs of youth in the community (i.e., academic enrichment activities, athletic skills building, study skills, etc.).

## **Largest Noncredit Offerings (Duplicated)**

Two-digit classifications of instructional program (CIP) codes provide additional information about the areas where noncredit instruction was provided. Percentages cited are based on known CIP codes.




Figure 10. Largest Noncredit Offerings (Duplicated), FY 2022

Across all categories of activity, six programs (two-digit CIP) had over 5,000 noncredit course enrollments. These six program areas accounted for nearly two-thirds (65.5 percent) of enrollments in noncredit courses where CIP data were reported. Approximately two out of five enrollments in these six programs accounted for in Figure 10 were in work-related programs: Health Professions and Related Programs (13.9 percent); Business, Management, Marketing, and Related Support Services (12.7 percent); Transportation and Materials Moving (10.1 percent); and Homeland Security, Law Enforcement, Firefighting, and Related Protective Services (6.5 percent). The two largest programs were in the following areas: Leisure and Recreational Activities (N = 32,674; 31.6 percent) and Personal Awareness and Self-Improvement (N = 25,982; 25.2 percent). ## Noncredit Term of Attendance (Duplicated)

Term of enrollment was provided for all noncredit coursework for fiscal year 2022 (see Table B-9). The distribution of enrollments by term was as follows: Spring (42.1 percent), Fall (32.7 percent), and Summer (25.2 percent). Overall, the distribution is similar to fiscal year 2022 credit offerings with higher spring noncredit activity and fewer summer noncredit enrollments.

# Noncredit Enrollment Distribution by Site/Location (Duplicated)




Figure 11. Noncredit Distribution by Site/Location, FY 2022

For state reporting purposes, six instructional site locations have been identified: Main Campus, Off-campus College Owned, Off-campus College Leased, Community Based, Business Based, and Distance Education. Acquiring more complete information about community college facility utilization and needs was one of the underlying reasons for collecting more detailed noncredit data. Complete data were available on the instructional site and Figure 11 shows that over two-fifths of enrollments occurred on main college campuses and one-fifth took place via distance education. It is a shift from last year when about thirty percent of enrollments occurred on main campus and two-fifths of the enrollments took place via distance education (see Table B-8).

Further information about the differences between the categories follows. Community-based sites are rented or leased, with site maintenance and upkeep the responsibility of the organization furnishing the space. Off-campus college-leased sites are controlled by

the college with site maintenance and upkeep the responsibility of the college. Off-campus college-owned facilities are college-controlled branch or extension center sites located away from the main campus. Business-based sites are provided by businesses that contract for training services. Distance Education includes internet-based courses.

## FISCAL YEAR 2022 COMPLETIONS

## **Degrees and Certificates Awarded by Community College**

The number of collegiate-level degrees and certificates awarded to Illinois community college students in fiscal year 2022 totaled 64,797. The number of community college completions in fiscal year 2022 is the seventh highest level ever reported. Table 4 contains comparative completion data for the last five years. The number of degrees and certificates awarded increased 4.9 percent from the previous year. Compared to fiscal year 2018, the total number of fiscal year 2022 completions increased 0.2 percent.

Table C-1 in the appendix provides a comparison of fiscal year 2018 through fiscal year 2022 duplicated completions for each community college. Compared to last year among the 48 colleges, 25 experienced increases in degree and certificate awards, while 21 exhibited decreases in the past year. Two colleges experienced little or no change. Beginning in fiscal year 2014, the Annual Completions (A2) submission is the source of completions data.

## **Degrees and Certificates Awarded by Program Categories**

Just over half of the 64,797 completers during fiscal year 2022 received **Career and Technical Education** degrees or certificates (55.5 percent). Transfer degrees and certificates were the second most frequently awarded and accounted for 40.3 percent of all the collegiate-level completions (see Table C-2).

Looking at the trends over time, overall Career and Technical Education completions increased (11.4 percent) compared to last year. Accordingly, a comparison of overall fiscal year 2022 Career and Technical Education completions to those granted five years earlier reveals that the total number of awards decreased by 12.1 percent. Career and Technical Education awards recorded across the board long-term decreases. Since 2018, there has been a decrease in short-term career certificates, which include Certificates of Nine to less than Thirty Semester Hours and Certificates of less than Nine Semester Hours (-2,575 graduates, or -10.7 percent). The number of longer-term career certificates awarded also decreased (-1,150 graduates or -18.1 percent). Between fiscal years 2018 and 2022, there was also a decrease in Associate in Applied Science degrees (-1,207 graduates or -11.4 percent). There were no Vocational Skills Certificates awarded in fiscal years 2018-2022.

A closer examination of the categories of formal awards issued within Career and Technical Education in fiscal year 2022 shows that more than one-half (59.5 percent) of the completions was Career Certificates of Less than One Year. About one-fourth was Associate in Applied Science degrees (26.1 percent). Longer-term Career Certificates accounted for 14.5 percent of the career program completions (see Table C-2).

The total number of **Transfer** degrees and certificates awarded decreased 3.2 percent compared to last fiscal year. The overall number of Transfer degrees and certificates awarded in fiscal year 2022 increased from fiscal year 2018 (26.4 percent, N = +5,458).

A handful of colleges began awarding the General Education Core Curriculum (GECC) Credential in fiscal year 2019 (N = 405). The GECC Credential is a credential provided by the college for completion of 37 to 41 credit hours to satisfy the General Education Core Curriculum of the Illinois Articulation Initiative. In fiscal year 2020, many more colleges began awarding GECC Credentials, and the number awarded sharply increased to 8,819, and this trend continued in 2022, when 7,361 GECC Credentials were awarded, accounting for 11.4 percent of all completions.

Among Transfer degrees and certificates granted, the Associate in Arts (A.A.) degree was most commonly awarded. The proportion of A.A. degrees decreased to 50.2 percent in fiscal year 2022 from 51.4 percent the previous year. More than one-fourth (28.2 percent) of the Transfer degrees and certificates earned was the GECC Credential. Nearly one-fourth (18.5 percent) of the Transfer degrees and certificates earned was an Associate in Science degree (see Table C-2).

## **Summary of Graduates by Degree Categories**

## Gender of Graduates by Degree Category

During fiscal year 2022, more than half of the degrees and certificates was earned by females (56.0 percent). The degrees and certificates attained by the highest proportion of females were Short-term Certificates of less than Nine Semester Hours (65.2 percent), General Associate (64.0 percent), Associate in Arts (62.2 percent), GECC Credential (62.2 percent), Associate in Fine Arts (62.2 percent), and Associate in Applied Science (60.1 percent). Although small in overall number, the Associate in Engineering Science (N =

349) had the highest proportion of male graduates (81.7 percent, N = 285). Short-term Certificates of Nine to less than Thirty Semester Hours were the specific award category with the largest number of male graduates (N = 7,525). The male/female distribution within the Transfer and Career and Technical Education degree and certificate areas drive the overall gender proportion (see Table C-3).

## Racial Ethnic Origin of Graduates by Degree Category

Four in ten (41.0 percent) degrees and certificates in fiscal year 2022 were awarded to minority students (nonwhite). In Table C-4, more minority graduates completed Career and Technical Education degrees and certificates (N = 14,127) than Transfer degrees and certificates (N = 11,139).

Four out of every ten (42.7 percent) fiscal year 2022 Transfer degrees and certificates were earned by minority students. The majority of the Transfer credentials earned by minorities was Associate in Arts degrees (50.6 percent), while 29.0 percent was GECC Credentials, and 18.0 percent was Associate in Science degrees. The overall proportion of minority Transfer completers was similar to last year.




Figure 12. Associate Degrees Earned by Minority Students, Fiscal Year 2022

Latino students (N = 14,460) completed more than twice as many collegiate-level programs than did African American students (N = 6,700) in fiscal year 2022. Figure 12 illustrates the distribution of minority students who successfully completed degree and certificate programs in the Illinois Community College System during fiscal year 2022 (see Table C-4).

## Age of Graduates by Degree Category

Twenty-five percent of all completers were in the under 21-year-old age group (25.3 percent). The youngest graduates were in Transfer (52.7 percent) and Career and Technical Education (45.5 percent) programs. The 21-24 age group accounted for one-third (35.3 percent) of all graduates. Graduates between 25 and 30 accounted for nearly one-fifth (17.0 percent) of the total, and the 31-39 age group accounted for 12.3 percent.

Nearly half (46.4 percent) of the students 30 and under completed Transfer degrees and certificates, while 19.1 percent of graduates over the age of 30 completed Transfer programs. Three out of four (74.8 percent) graduates over 30 earned Career and Technical Education degrees and certificates. Generally, the proportion of Career and Technical Education graduates increased as student age advanced (see Table C-5).

## Intent of Graduates by Degree Category

Self-reported intent data disclose the primary goal a student wants to achieve as a result of studies. The community colleges examine current intent versus student intent at the time of initial enrollment at the college. In these analyses, available **current intent** was examined to reflect the changing needs and desires of the community college student. Seven out of every ten students (70.5 percent) who attained a Transfer degree or certificate in fiscal year 2022 indicated that they intended to prepare for transfer to a four-year institution. Seventeen percent of these successful students indicated a desire to either prepare for a job immediately after community college or to improve present job skills—intent that would most often be associated with seeking a Career and Technical Education degree or certificate.

Similarly, 54.2 percent of those students who attained a Career and Technical Education degree or certificate indicated they were preparing for a job immediately after completing community college or improving present job skills. Over one-fourth (28.3 percent) of the Career and Technical Education graduates indicated that they were preparing for transfer to a four-year institution. Pursuing a Career and Technical Education degree does not preclude a student from transferring to a four-year institution (see Table C-6).

## <u>Degree Objective of Graduates by Degree Category</u>

The self-reported degree objective provides an indication of the student's expected outcome from attending the community college. One might anticipate that they would mirror student completion patterns. Four out of five (80.9 percent) students who earned Transfer degrees and certificates in fiscal year 2022 indicated that they enrolled with a desire to complete an associate degree. However, one in six (16.8 percent) indicated that they wanted to complete only one or several courses and were not pursuing a degree.

A review of Career and Technical Education graduates reveals a similar pattern: 83.0 percent of the Career and Technical Education students who earned an Associate in Applied Science degree had listed completing an associate degree as their objective. One-sixth (17.0 percent) of these students planned to only complete one or several courses or

a certificate but ended up surpassing their goal by earning an Associate in Applied Science degree (see Table C-7).

#### **CLOSING COMMENTS**


Demand for the programs and services delivered by Illinois community colleges remain strong. During fiscal year 2022, the Illinois Community College System provided education and training to 503,579 students in credit and noncredit courses. More than three-fourths of these students were in credit courses. The 64,797 degrees and certificates awarded in fiscal year 2022 were the seventh highest number ever reported for Illinois Community College System graduates. This is an increase of 4.9 percent over last year and 0.2 percent from 2018.


