

## ILLINOIS COMMUNITY COLLEGE BOARD

### FALL 1999 ENROLLMENT SURVEY REPORT

Fall opening enrollment (E1) data for credit-generating students are recorded by the colleges at the end of the regular fall registration period, which is usually the 10th day. Historically, the census data have provided a "snapshot" of fall term enrollment for year-to-year and institution-to-institution comparisons and are used for comparison to fall enrollment data in postsecondary institutions nationwide. However, the diversities of the community college system and its students are not fully captured in these opening enrollment data. The expansion in module and late-starting classes along with the colleges' efforts to provide flexibility in scheduling from year to year increases the difficulty in reporting and comparing fall data. Enrollment trend data are best captured through the use of annual enrollment data.

Based on preliminary counts, headcount remained relatively unchanged while FTE decreased slightly for fall 1999. The number of students enrolled in credit courses at community colleges as of the end of registration for fall term 1999 was 340,845, an increase of 323 students (0.1%) from the fall term of 1998. The total fall 1999 FTE enrollment was 180,084, a decrease of 1,961 (-1.1%) from 1998. Preliminary counts are based on the Fall Enrollment Survey and are subject to verification upon receipt of fall enrollment (E1) data. Comments from administrators at the community colleges indicate that the decrease in FTE despite the stability of headcount enrollments is due to an increase in adult part-time, employed students.

Table 1 contains comparative fall census enrollments for the last five years. The previous year the Illinois Community College System had experienced a minor decrease in headcount enrollments, following two years of slight growth. FTE enrollments mirrored this trend, but with slightly larger increases and decreases than headcounts.

Figure 1. Opening Fall Headcount and FTE Enrollment, 1995-1999

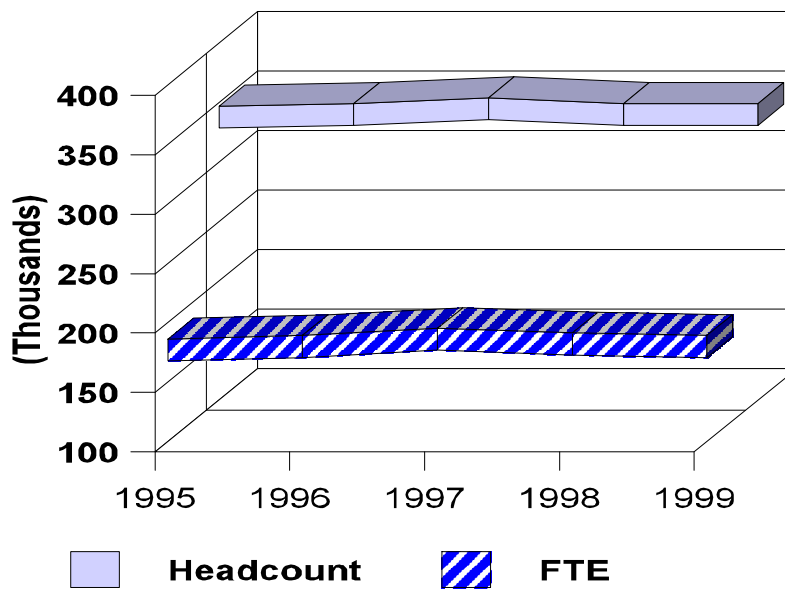


Table 2 provides a comparison of fall 1995 through fall 1999 headcount enrollments for each community college. Of the 48 community colleges, 25 colleges experienced increases in headcount, while 19 exhibited decreases during the past year. Four colleges experienced little or no change (less than one percent) over the last year. Table 3 contains a comparison of FTE enrollments for the five-year period. FTE increases were reported by 18 colleges, decreases by 22, and eight colleges indicated little or no change.

Table 4 provides a comparison of 1998 and 1999 fall headcount, for each community college, broken out into correctional and non-correctional enrollments. Table 5 shows a comparison of FTE enrollments, both correctional and non-correctional, for fall 1998 and fall 1999 at each community college.

Ten Illinois community colleges extended instructional services to correctional institutions in the fall semesters of 1998 and 1999. Correctional headcounts accounted for 0.8 percent of the statewide headcount and the overall FTE in fall 1999. These proportions are similar to correctional enrollments reported for fall 1998. An examination of only correctional enrollments reveals that headcount increased an estimated 19.4 percent, while FTE increased about 24.9 percent. Correctional program enrollment growth at Rend Lake College accounted for most of the statewide corrections enrollment increases in both headcount and FTE from fall 1998 to fall 1999.

Headcount enrollments that were exclusively non-correctional decreased 0.04 percent from fall 1998 to fall 1999, comparable to the overall headcount increase of 0.1 percent. The overall FTE decrease of 1.1 percent was comparable to the decrease of 1.2 percent in non-correctional FTE enrollment.
