## FALL 2008 OPENING ENROLLMENT SURVEY RESULTS

Statewide Results. Overall, statewide Illinois Community College System opening Fall 2008 enrollments are up compared to last fall. These opening enrollments reflect the end of the regular fall registration period which is usually the 10th day of class. Systemwide, Fall 2008 enrollments showed an increase in headcount ( +1.9 percent) and an increase in the number of Full-time Equivalent (FTE +2.7 percent) enrollments compared to last year. Statewide compared to last fall, more students were attending a community college and those attending took more credits.

The number of students enrolled in credit courses at Illinois community colleges as of the end of regular registration for Fall 2008 was 353,742 or 6,465 more than last fall. Statewide FTE enrollment was 202,851 which is up the equivalent of 5,378 full-time students from Fall 2007. These preliminary counts are from the internet based Fall 2008 Enrollment Survey and results are subject to verification upon receipt of the detailed Fall Enrollment (E1) data submission.

Table 1 provides systemwide comparative fall census enrollment counts for the last five years. Statewide opening headcount enrollments increased slightly after the four consecutive years of decreases. This year's statewide FTE enrollment increase marks the second year that the FTE enrollment has grown. Current opening fall statewide FTE is similar to the corresponding Fall 2004 FTE.

Results by College. Table 2 provides comparative information by college of Fall 2004 through 2008 headcount enrollments. A one-year comparison between Fall 2007 and Fall 2008 among the 48 community colleges shows that twenty-one colleges exhibited headcount enrollment increases of one percent or above. Fifteen colleges reported headcount decreases of one percent or more. The remaining twelve colleges experienced little or no change (less than one percent).

Table 3 provides a college level comparative data on FTE enrollments for the most recent fiveyear period. The number of colleges with FTE enrollment increases lead those who reported FTE declines (2.5:1). Over the past year, FTE increases were reported by 30 colleges, decreases by 12 , and six colleges registered little or no change.

Updated Results for Students in Correctional Facilities. Table 4 provides a comparison of 2007 and 2008 fall headcount enrollment for each community college, broken out by correctional and non-correctional student enrollment. Table 5 shows a comparison of FTE enrollment correctional and non-correctional students - for Fall 2007 and Fall 2008 by community college. Eleven Illinois community colleges furnished instructional services to correctional facilities during the Fall semester of both 2007 and 2008. In the latest data, there were 3,289 students in correctional facilities which accounts for 0.9 percent of the statewide headcount.
Proportionately, this was the same as in Fall 2007 ( 0.9 percent). Similarly, students in
correctional facilities accounted for 0.8 percent $(1,534)$ of the overall FTE enrollment in Fall 2008 which is similar to Fall 2007 ( 0.9 percent). An examination of only student enrollments in correctional facilities reveals a headcount increase of 8.2 percent (250) and an FTE decrease of 18.4 percent (-346 FTE). Exclusively non-correctional headcount enrollment increased (1.8 percent) from Fall 2007 to Fall 2008. The non-correctional FTE enrollments increased 2.9 percent.

Results for Internet Enrollment by College. Fall 2008 is the first year that internet enrollments have been reported from all colleges in the Opening Fall Enrollment Survey. Table 6 provides duplicated and unduplicated headcount internet enrollment for Fall 2008. There were 67,835 duplicated internet enrollments and 45,713 unduplicated internet enrollments for Fall 2008. Based on unduplicated beginning of term counts, in Fall 2008 internet headcount enrollments accounted for 12.9 percent of overall headcount enrollments.

Table 7 provides opening internet FTE enrollment for Fall 2008. There were 14,327 internet FTE enrollments. In Fall 2008, internet FTE enrollments accounted for 7.1 percent of overall opening FTE enrollments.

Additional Background. Fall opening enrollment information for credit-generating students are recorded by the colleges at the end of the regular fall registration period, which is typically the 10th day of class. Opening fall enrollment data are gathered from postsecondary institutions nationwide. Historically, these counts provide a "snapshot" of opening fall term enrollment for year-to-year and institution-to-institution comparisons. The diversity of the community college system and its students is not fully captured in these opening enrollment data. Colleges actively seek out opportunities to serve students that may not fit into the traditional reporting framework. Modules within terms/late-start classes and internet based course delivery are some examples of college outreach efforts. Providing increasingly flexible scheduling from one year to the next is necessary to accommodate student schedules and compete successfully in the marketplace. Hence, enrollment trends are more fully captured through use of annual data.
