As a reminder, here is the complete Board Goal statement as adopted:

- Alternative Methods of Credentialing (High School Equivalency): A statewide initiative to offer three alternative credentialing options to adults without a high school diploma.
 - ✓ IMPACT: This initiative has the potential to reach an estimated 3-5% of the 662,000 individuals without a high school diploma who have earned at least 13.5 high school credits.

STATUS	ACTIONS
6/7/2019	Training to regional offices and adult education programs. Local review of transcripts.
1/24/2020	Thirty transcripts reviewed; three awards made. Reviewing criteria.
6/12/2020	Forty-three transcripts reviewed. No additional awards. Review of criteria continues.

- Common Placement Framework: This Presidents' Council and ICCB led initiative has developed a multiple measure, common placement framework for the community college system.
 - ✓ IMPACT: All students in the community college system by establishing greater consistency and more opportunities for placement into credit-bearing coursework.

STATUS	ACTIONS
6/7/2019	Implementation guide/research agenda under development. Congruent with SJR 41 work.
1/24/2020	Sixteen colleges implemented in the fall of 2020.
6/12/2020	Eighteen colleges are fully implemented; 13 additional colleges implemented by fall 2020.

- The Comprehensive Agreement Regarding the Expansion of Educational Resources (CAREER) Agreement Management: The CAREER agreement allows students to attend an out-of-district institution at in-district rates if the home district lacks a program desired by the student.
 - ✓ IMPACT: The CAREER agreement provides significant cost relief and enhances access for the approximately 132,000 CTE students in the system.

STATUS	ACTIONS
6/7/2019	Negotiating about agreement modifications, including issues around out of district marketing
1/24/2020	The ICCB approved the revised CAREER agreement.
6/12/2020	Ten colleges have adopted the revised agreement.

- **Dual Credit Oversight and Administration:** Dual credit instruction allows academically prepared high school students to earn credits that count toward a high school diploma and a college degree.
 - ✓ IMPACT: 59,039 individual high school students enrolled in dual credit courses for an 8.6 percent increase from the previous year. Duplicated enrollment stands at 124,614.

STATU	S ACTIONS
6/7/201	The ICCB maintains oversight over dual credit on community college campuses.
1/24/20	Administrative rule updates were in progress to reflect the Dual Credit Quality Act (DCQA).
6/12/20	The COVID-19 pandemic delayed the progress of the administrative rules.

- **Dual Credit Quality Act:** The Act mandated several changes to dual credit, including the development of a Model Partnership Agreement (MPA) and an endorsement on the professional education license.
 - ✓ IMPACT: The MPA provides a default agreement high schools and colleges. Up to 2400 high school, dual credit instructors could benefit from the dual credit endorsement.

STATUS	ACTIONS
6/7/2019	MPA approved by the ICCB; Dual credit endorsement framework in draft form.
1/24/2020	Procedures around dual credit faculty endorsements were released in November 2019.
6/12/2020	An initial count of the dual credit endorsements will be available this summer.

- Gates Foundation Early Indicators of Student Success Project: In partnership with the City University of New York (CUNY), and other states, ICCB examined analyzed student success in the second year.
 - ✓ IMPACT: Dissemination will benefit local colleges with the use of predictive metrics and models to assist with service prioritization for students.

STATUS	ACTIONS
6/7/2019	ICCB's participation in this project was complete.
1/24/2020	Waiting for CUNY's dissemination of findings.
6/12/2020	Journal submission in progress. Nathan Wilson and Jay Brooks are co-authors.

- *General Education Core Curriculum (GECC) Credential:* A credential designed for students who completes the required 37 41 general education hours in the Illinois Articulation Initiative (IAI).
 - ✓ IMPACT: Nearly 20,000 students per year can potentially benefit from this credential.

STATUS	ACTIONS
6/7/2019	Twenty-four colleges have applied and been approved.
1/24/2020	Thirty-seven colleges approved to date. Four hundred and five credentials awarded.
6/12/2020	Forty colleges approved to offer the GECC as of May 2020.

- *Illinois Articulation Initiative (IAI):* This ICCB and IBHE co-led initiative allows students to transfer seamlessly across nearly 100 Illinois institutions.
 - ✓ IMPACT: The IAI is central to the experience of the 265,000 annual transfer students.

STATUS	ACTIONS
6/7/2019	6,897 active GECC and 2,344 active Major courses. 9,241 active courses in IAI. (FY2018)
1/24/2020	6,818 active GECC and 2,351 active Major courses, 9,169 active courses in IAI. (FY2019)
6/12/2020	6,889 active GECC and 2,397 active Major courses., 9,286 active courses in IAI (FY2020)

- Office of Civil Rights Visits: Federal law requires ICCB to conduct annual civil rights visits to colleges based upon our receipt of Carl D. Perkins Career and Technical Education Act funds.
 - ✓ IMPACT: This requirement ensures colleges are meeting the needs of students with disabilities and other barriers and serves as an important lever for change on campus.

STATUS	ACTIONS
6/7/2019	ICCB typically selects and notifies colleges in September each year.
1/24/2020	Two college visits were scheduled.
6/12/2020	The COVID-19 pandemic has delayed FY2020 visits.

- *Open Educational Resources (OER):* A statewide initiative to increase the use and adoption of OER course materials as a strategy to reduce textbook costs and financial barriers for students.
 - ✓ IMPACT: OER increases college access and affordability by reducing the cost to attend college. It has the potential to dramatically cut costs for all students in the system.

STATUS	ACTIONS
6/7/2019	Planning meetings; CTE GAP analysis; OER summit and workshop in development.
1/24/2020	A survey was developed on institutional use of OER.
6/12/2020	Due to COVID-19, the OER conference has moved to fully online.

- *Postsecondary Equity Targets Workgroup:* This P-20 Council led project is developing a framework and proposed targets for Illinois to make progress in closing equity gaps in postsecondary attainment.
 - ✓ IMPACT: Greater focus on equity gaps in the completion agenda.

STATUS	ACTIONS
6/7/2019	MHEC contracted to generate prediction and goal models for consideration.
1/24/2020	ICCB, IBHE, and MHEC executed a data sharing agreement.
6/12/2020	MHEC will model data to inform policy about attainment gaps for disadvantaged students.

- Student Transfer Achievement Reform (STAR) Act (110 ILCS 150/): This act requires the ICCB and IBHE to implement rules pertaining to reverse transfer.
 - ✓ IMPACT: Students who transfer without a degree but earn enough credits to reach the associate degree will have an opportunity to earn their associate degree through this process.

STATUS	ACTIONS
6/7/2019	ICCB approved a draft of the administrative rules.
1/24/2020	JCAR published reverse transfer rules on Dec 27, 2019. STAR act report filed Jan 9, 2020.
6/12/2020	Rules are final. All public institutions will have processes developed by fall 2020.

- *Transitional English:* Transitional English will allow students to prepare for college level coursework while still in high school in order to avoid remediation.
 - ✓ IMPACT: The reduction of remediation for the nearly 20 percent of first time, full-time high school students that would otherwise enter into remedial courses in their first year of college.

STATUS	ACTIONS
6/7/2019	Ongoing discussions with ISBE about implementation.
1/24/2020	Twelve colleges received funding to implement.
6/12/2020	The competencies have been made available for public comment beginning June 1 st .

- *Transitional Math (TM):* TM allows students to prepare for college level coursework while still in high school in order to avoid remediation. Successful students enroll at the college without a placement test.
 - ✓ IMPACT: Over time, TM is likely to reduce remediation for the 50 percent of first time, full-time high school students that would otherwise enter into remedial math in their first year.

STATUS	ACTIONS
6/7/2019	All 39 community college districts were collaborating with high schools to implement.
1/24/2020	Twenty-one colleges submitted courses for statewide portability.
6/12/2020	COVID-19 delays. Twenty-five districts have at least one course approved.

• *Transfer Compact Project Proposal:* A revised transfer compact would incorporate the many updates and changes to the landscape of higher education since the last compact was developed.

✓ IMPACT: This work will have broad implications for students and institutions, enhancing seamless transfer and articulation.

STATUS	ACTIONS
6/7/2019	A workgroup reviewed the STAR Act, PLA efforts, IAI and the AP Equity bill.
1/24/2020	The final report for SJR 22 was submitted.
6/12/2020	Community college and university CAOs are vetting expanded recommendations.

GOAL 2: Contribute to economic development by supporting the Illinois community college system's effort to provide robust workforce training, to expand apprenticeships, to increase credential attainment, to build quality career pathways, and to address the future needs of the Illinois workforce.

- Adult Education Strategic Plan (AESP): This plan charts a progressive course for the ICCB's nationally recognized Adult Education and Literacy Program.
 - ✓ IMPACT: The potential to affect 59,769 adult education students served in Illinois.

STATUS	ACTIONS
6/7/2019	The AE Advisory Council recommended the enhanced development of IETs.
1/24/2020	IET programming was incorporated into the CAP-IT Apprenticeship grant.
6/12/2020	Fifteen programs were awarded funding to modify content relative to IET programs.

- *Adult High School Diploma:* Allows the establishment of Adult High School Diploma Programs, with ICCB approval, when applicants cannot establish agreements with secondary or unit school districts.
 - ✓ IMPACT: This law has the potential to provide a pathway to a high school diploma for the approximately 662,000 individuals with over nine grades of education.

STATUS	ACTIONS
6/7/2019	No applications received.
1/24/2020	Inquiries, but no applications received.
6/12/2020	Receiving informal inquiries; Reviewing language and making adjustments as needed.

- *Program Review*: ICCB coordinates a statewide program review system (see P.A. 78-669). Community colleges are required to submit a review of programs once every five years to the ICCB.
 - ✓ IMPACT: This process provides an additional continuous quality improvement check for colleges to ensure the 39 districts are providing high quality programming.

STATUS	ACTIONS
6/7/2019	Revisions to the Program Review Manual released to the system.
1/24/2020	As of January 2020, staff were reviewing colleges' program review reports.
6/12/2020	All colleges will receive feedback by June 30, 2020 on their FY2019 program reviews.

- Scaling Apprenticeship Through Sector-Based Strategies Grant (formerly Apprenticeship Grant Application): The ICCB received a four-year \$4 million Department of Labor to work with business to develop pre-apprenticeship and apprenticeship programs. Ten college self-selected to participate in the project.
 - ✓ IMPACT: This grant will serve more than 1,728 individuals at ten community colleges.

STATUS	ACTIONS
6/7/2019	Not released (received post-June Board meeting, July 15, 2019).
1/24/2020	The ICCB held its first Advisory committee meeting on January 16, 2020.

- Workforce Education Strategic Plan (WESP): This plan was designed to ensure the community college system remains a leader in the complementary fields of workforce training and education.
 - ✓ IMPACT: This plan focuses on better aligning the programs of community colleges to the workforce needs of the state. It has the potential to affect all students served by the system.

STATUS	ACTIONS
6/7/2019	Statewide listening sessions; Surveys on the four strategic goals were developed.
1/24/2020	Surveys vetted with the Presidents Council (earlier in the year), due February 14, 2020.
6/12/2020	The survey results suggested extensive activities between K-12 and community colleges.

GOAL 3: Increase access and completion for students through the alignment of policies and enhanced data transparency to improve system effectiveness.

- *Illinois Postsecondary Profiles (IPP):* The IPP is a joint ICCB/IBHE web site through which interested stakeholders can access actionable data pertinent to the postsecondary experience.
 - ✓ IMPACT: This web portal provides important information to the public, researchers, and other interested parties about Illinois higher education.

STATUS	ACTIONS
6/7/2019	In March of 2019, the IPP pilot website shared broadly with constituents.
1/24/2020	The September 2019 Board meeting included a demo of the IPP interactive website.
6/12/2020	The "Professional" Profile website design was completed and is being shared for feedback.

- *Perkins V Transition:* The purpose of the recently reauthorized Strengthening Career and Technical Education Act (Perkins V) is to develop more fully the academic knowledge and technical and employability skills of who elect to enroll in CTE programs and programs of study.
 - ✓ IMPACT: Effects every high school and community college student in a CTE program.

STATUS	ACTIONS
6/7/2019	ISBE and ICCB submitted the Perkins V transition plan on May 24, 2019.
1/24/2020	Plan feedback was solicited via "Roadshows," presentations, and public comment.
6/12/2020	The Perkins V plans was approved and rollout of the revised plan is underway.

- *Postsecondary Data Partnership (PDP):* The purpose of this National Student Clearing House led initiative is to pilot multiple accessible data dashboards for colleges around the nation.
 - ✓ IMPACT: This work will provide important information to the public, researchers, and other interested parties about Illinois higher education.

STATUS	ACTIONS
6/7/2019	ICCB and other states were in discussion about the ability to meet the deliverables.
1/24/2020	ICCB participated in a national convening to discuss the project processes and value added.

PROPOSED HIGH SCHOOL EQUIVALENCY EXAM PRICING CHANGES

The ICCB staff is requesting the approval of two amendments to the current High School Equivalency (HSE) pricing structure for the Data Recognition Corporation - TASCTM and Educational Testing Services - HiSET®.

Data Recognition Corporation has proposed an amendment to the current MOU for a price increase for the TASC High School Equivalency paper-based exam. This price increase would be effective immediately upon approval by the Illinois Community College Board (ICCB). The proposed price increase for the TASC exam affects only the paper-based test, as the cost of production has increased. A comparison of the current 2020 prices and the proposed price increase is included below:

Given the impact of the COVID-19 virus on the availability of high school equivalency testing at physical testing centers in Illinois, Educational Testing Center has developed an online proctored exam titled-HiSET Exam at Home" and will be available on June 15, 2020. The HiSET Exam at Home will require a different pricing structure than the paper-based and computer-based HiSET exams. The proposed price changes for the HiSET exam affects **only** the new online proctored HiSET Exam at Home. All other pricing structures for the exams will remain the same. A comparison of the proposed price of online HiSET testing to current computer-based and paper-based HiSET testing is included below:

Amendment No. 002 Memorandum of Understanding State Of Illinois Community College Board And Data Recognition Corporation

This Amendment No. 002 ("Amendment 002") made effective as of February 3, 2020 ("Effective Date") by and between Data Recognition Corporation, with an office at 13490 Bass Lake Road, Maple Grove, Minnesota 55311 ("DRC") and the State of Illinois Community College Board ("ICCB") with an office at 401 E. Capitol Avenue, Springfield, Illinois 62701-1711, (DRC and ICCB shall be referred to herein individually each as a "Party" and collectively as "the Parties").

Whereas, the Parties, entered into a Memorandum of Understanding (MOU) effective August 11, 2015 for the administration of TASC Test Assessing Secondary Completion ("TASC Test") product, (the "Agreement"); and

Now therefore, the Agreement is hereby amended as follows:

This Exhibit 2 of the MOU sets forth all terms and conditions specific to the remote proctoring delivery of HiSET exam and is subject to the terms of the MOU.

2. **DEFINITIONS**

"eREG" shall mean ETS's online Test Registration portal located at https://hiset.ets.org/.

"<u>HISET</u>" shall mean the remote proctoring version of the CBT HISET Exam available for registration beginning on June 15, 2020. Eligible Test Takers will register for each Subtest online through eREG. ETS's remote proctoring provider will email a link for the Test Taker to schedule the Subtest.

"Test(s)" shall mean each HiSET Exam at Home Subtest.

3. TERMS

- <u>Test Taker Registration</u>. Test Taker will register for the Subtest online through eREG. ETS's remote proctoring provider will email a link for the Test Taker to schedule the Subtest.
- 3.2 Test Center Fee. In addition to the fees set forth in Exhibit 1 of the MOU, Test Takers will pay \$17.50 per Subtest upon HiSET Exam at Home registration instead of the current \$8 Test Center fee to test at a physical location as set forth in Exhibit 1. The fee may be changed at any time at ETS's sole discretion with written notice to Client and this Exhibit 2, Section 3.2 shall be deemed amended accordingly. Registrations after such fee change shall be subject to the new fee.
- 3.3 <u>State Fees.</u> ETS will collect any State fees, if applicable, upon registration for the Test and remand payment to the State according to the MOU.

College of DuPage Project Higher Ed Apprenticeship Certificate (30 credit hours)

Program Purpose: This program will prepare individuals for entry-level employment, further education and apprenticeships in the areas of manufacturing machining, computerized numerical control, facilities maintenance, industrial maintenance, heating/air conditioning, welding, or electromechanical/mechatronics technology.

Catalog Description: This program will allow students an opportunity to pursue multiple training and apprenticeship opportunities. This program will develop a bridge between multiple existing college programs, allowing for entry-level employment credentials stackable towards advanced-level Certificates and A.A.S. degrees.

Curricular Information: The curriculum consists of 12 credit hours of required career and technical coursework in industrial safety, introductory workplace safety, materials and equipment, customer service, workplace writing, Microsoft Office for Professionals, and a Project Higher Education Seminar. The remaining 18 credit hours of coursework will be selected from one of seven (7) specialty areas: manufacturing machining, computerized numerical control, facilities maintenance, industrial maintenance, heating/air conditioning, welding, or electro-mechanical/mechatronics technology. Each specialty track also requires a work-based learning component with a local employer. Assessment of student learning will be achieved through evaluation of the student's soft skills through the seminar course, and of their performance during the work-based learning component of the curriculum.

Justification for Credit hours required: NA.

Accrediting Information: NA.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the need for a program of this nature. According to the Illinois Department of Employment Security (IDES), growth in the employment of related occupations including "production occupations, installation/maintenance/repair occupations, and building maintenance occupations" is expected to increase by approximately 1.5% statewide through the year 2026.

Kennedy-King College Game Design and Development Associate of Applied Science degree (A.A.S.) (61 credit hours)

Program Purpose: This program will prepare individuals for entry-level employment, as well as advancement opportunities, in the gaming industry as game designers, environmental artists, gameplay engineers and multimedia designer/animators.

Catalog Description: The Associate of Applied Science (A.A.S.) in Game Design and Development is designed to provide entry-level employment training, support the pursuance of advancement opportunities, and provide entrepreneurial training for those seeking to enter the gaming industry. The program is a two-year, career and technical degree program that blends art, design and technology to create interactive games for market. Game design, prototyping, programming, testing, production and management are all skills the program addresses. Additionally, the degree program will provide future transfer opportunities to local universities offering baccalaureate level Game Design and Development programs.

Curricular Information: The curriculum consists of 16 credit hours of required general education coursework, and 45 credit hours of required career and technical education coursework.

The career and technical component includes instruction in introductory communication design, freehand drawing, introductory through advanced levels of game design, introductory through advanced levels of creating art of the game, game programming, gamification, game studio, introductory and intermediate levels of motion graphics, business of games, and game development and society. Assessment of student learning will be achieved through evaluation of the student's performance during the Game Studio course, which will require a comprehensive design and production of a playable video game. The curriculum was also designed to articulate towards several local baccalaureate degree programs, such as DePaul University's Bachelor of Science in Game Design, and Columbia College's Bachelor of Arts in Game Design.

Justification for Credit hours required: The curriculum was designed to address the needs of local employers by including the necessary gaming skills for successful employment in the field. The curriculum was also designed to provide maximum articulation towards a related baccalaureate degree curriculum, which includes a four (4) credit hour technical mathematics course.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the need for a program in this field of study. <u>College of Lake County</u> Cybersecurity Certificate (30 credit hours)

Program Purpose: This program will prepare individuals for entry-level employment, and advancement, in the field of information security.

Catalog Description: The Cybersecurity Certificate program will prepare students to protect businesses and institutions that currently use electronic commerce from malicious cyber-attacks and data theft. Managing information security is achieved through confidentiality, data and system integrity and availability. The certificate is based on information security concepts, principles, methods, techniques, practices, and procedures that guide today's IT security professionals. This program prepares graduates to become employed as Cybersecurity specialists, Security analysts, vulnerability analysts, Firewall and VPN specialists. Coursework includes foundational courses in network operating systems and network automation. This is followed by coursework in the cybersecurity field, so students understand and know how to look for weaknesses and vulnerabilities in target systems. The certificate is designed for professionals returning to upgrade skills or students who are interested in obtaining employment skills in IT security professions. The certificate can be completed as a student progresses through the CIT A.A.S. degree program with the specialty option of Network Administration and Cybersecurity. After completion of this coursework, the student will be prepared to take certification exams for Security+, Linux+, C\EH, CySA+, and CISCO Cybersecurity Cyber Ops.

Curricular Information: The curriculum consists of 30 credit hours of required career and technical coursework in Windows Operating Systems, Linux Operating Systems, Network Automation, CISCO: Introduction to Networks, Windows Server Administration, Network Security Fundamentals, Ethical Hacking, Hardening the Infrastructure, Network Defense and Countermeasure, and Cybersecurity Analysis. Students will be prepared for various industry credentialing exam including for CompTIA's Security+, Linux+, and CySA+ certifications, Certified Ethical Hacker (CEH) certification through EC-Council, and CISCO Cybersecurity Cyber Ops certification. This certificate also fully articulates towards the college's existing Computer Information Technology (CIT) A.A.S. degree. Assessment of student learning will be achieved through evaluation of the performance on comprehensive assignments throughout the program designed to measure achievement of core competencies and during the CIT 253 Network Defense and Countermeasure capstone course which requires completion of a comprehensive project.

Program Purpose: This program will prepare individuals for entry-level employment as commercial chemical and fertilizer applicators.

Catalog Description: The Commercial Applicator Certificate program prepares students for a career in the crop input field. Students will be provided hands on training, utilizing some of the latest in technology equipment.

Moraine Valley Community College Advanced Supply Chain Management Certificate (41 credit hours)

Program Purpose: This program will prepare individuals for entry-level and advancement opportunities in the field of supply chain management overseeing the flow of goods, data, and finances as a product or service moves from point of origin to its final destination.

Catalog Description: The Advanced Supply Chain Management Certificate program is an application-based program that provided students with advanced supply chain management principles. Key topics covered include core technology skills and business/industry content. Students will address both domestic and global issues in supplier and customer relations, value-added product differentiation, cost management, and the professional skills required to succeed within this industry. The program has been designed based on current industry needs and in consultation with logistics and supply chain leaders. Students participating in this program will gain background knowledge for advanced level positions or, if currently employed in the industry, enhanced professional knowledge and career advancement potential.

Curricular Information: The curriculum consists of 41 credit hours of required career and technical coursework in introduction to business, MS Office, transportation and logistics industry overview, global transpiration, principles of operations management, business law, principles of management, introductory import/exporting, cargo security, warehousing and distribution, probability and statistics, advanced supply chain technologies, and quality control and customer service.

The college's recently approved Introduction to Supply Chain Management Certificate fully articulates into this proposed Advanced Certificate. Assessment of student learning will be achieved through evaluation of the performance on comprehensive assignments throughout the program designed to measure achievement of core competencies.

Justification for Credit hours required: The curriculum was designed to address the needs of local employers. Course content related to statistics, business law, quality control, customer service and basic office applications was considered critical for an individual's success in management in the field of transportation, distribution and logistics.

Accrediting Information: NA.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the need for a program in this field of study. According to the Illinois Department of Employment Security (IDES), growth in the employment of occupations related to the transportation, distribution and logistics industry are expected to increase by an average of 6.5% statewide through the year 2026.

<u>Southwestern Illinois College</u> Practical Nursing Certificate (36 credit hours)

Program Purpose: The certificate will prepare individuals for employment as Licensed Practical Nurses (LPNs) in a variety of healthcare settings.

Catalog Description: The SWIC Practical Nursing program prepares students with the basic skills necessary to become a Licensed Practical Nurse (LPN). LPNs are on the front line of nursing, interacting with patients on a daily basis in settings including hospitals, long-term care settings, doctors' offices, outpatient clinics or even home health. They work under the supervision of a registered nurse or physician and sometimes oversee certified nurse assistants. PNs provide basic bedside care for the sick, injured and convalescent, and do tasks such as give injections, take vital signs, collect samples, perform diagnostic tests, dress wounds, administer medication and report status of the patient. The program is designed to include classroom education, auto-tutorial lab, simulation experiences and clinical application in long-term care, hospital, and healthcare office settings.

In accordance with the Illinois Nursing and Advanced Practice Nursing Act, 2017, the purpose of the Practical Nursing Education curriculum at SWIC is to prepare students to:

- 1. Apply for the NCLEX-PN exam after successful completion of the program and to apply for licensure as registered practical nurse after successfully completing the NCLEX-PN.
- 2. Practice entry-level practical nursing only under the direct supervision of the registered practical nurse until item No. 1 has been accomplished.
- 3. Practice practical nursing at a beginning staff level after successfully completing the NCLEX-PN and receiving licensure as a registered practical nurse.

Curricular Information: The curriculum consists of 36 credit hours of coursework in fundamentals of nursing, foundations of nursing, nutrition in nursing, human body structure and function, pharmacology, mental health nursing, obstetric and pediatric nursing, pediatrics in practical nursing, introductory and advanced medical surgical nursing. The curriculum also requires clinical/work-based learning. Assessment of student learning will be achieved through evaluation of the student's performance on practice licensure exams and during the clinical/work-based learning component of the program.

Justification for Credit hours required: The curriculum was developed to meet the requirements of the Illinois Department of Finance and Professional Regulation (IDFPR) and the Nurse Practice Act. The curriculum will prepare students for successfully taking the National Council Licensure Examination for Practical Nurses (NCLEX-PN), a requirement for employment. The content and clinical hours required exceeds 30 credit hours.

Accrediting Information: Program accreditation is not required in Illinois, however, IDFPR must approve the college's feasibility study and curriculum, following all appropriate State-curricular approvals and prior to enrolling students.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the need for training program in this field of study. According to the Illinois Department of Employment Security (IDES), growth in the employment of "licensed practical nurses" is expected to increase by 2% statewide through the year 2026, and by 11% nationwide through the year 2028.

South Suburban College Emergency Medical Services-Paramedic Associate of Applied Science degree (A.A.S.) (60 credit hours)

Program Purpose: This program will prepare individuals for entry-level employment, and advancement opportunities, in the field of emergency medical services as a paramedic.

Catalog Description: The Associate of Applied Science (A.A.S.) in Emergency Medical Services program trains students in basic emergency care, intubation and how to administer medications. This degree requires two years of full-time study to complete. Programs combine classroom work with extensive hands-on training in ambulances and hospital emergency departments. Students earn emergency medical technician (EMT) certification and graduates will qualify to take the paramedic certification examination.

Curricular Information: The curriculum consists of 16 credit hours of required general education coursework and 44 credit hours of required career and technical education coursework. The career and technical component includes instruction in introductory through advanced levels of emergency medical services, emergency medical trauma, respiratory care, cardiovascular care, obstetrics and pediatrics, and a required work-based learning experience in emergency medical services. The curriculum will prepare students for required licensure as an Emergency Medical Technician-Paramedic (EMT-P) through the Illinois Department of Public Health (IDPH), and for optional National credential through the National Registry of Emergency Medical Technicians (NREMT). Assessment of student learning will be achieved through evaluation of the student's performance during laboratory participation and the work-based learning experience by program faculty and the worksite supervisor.

The proposed degree also provides an educational ladder opportunity for students and graduates of the college's existing EMT-Basic Certificate and EMT-Paramedic Certificate.

Justification for Credit hours required: NA.

Accrediting Information: The curriculum was developed according to standards for program accreditation of the Commission on Accreditation of Allied Health Education Programs-Committee on Accreditation of Educational Programs for Emergency Medical Services Professions (CAAHEP-CoAEMSP).

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the need for a program in this field of study. According to the Illinois Department of Employment Security (IDES), growth in the employment of "emergency medical technicians & paramedics" are expected to increase by 9.6% statewide through the year 2026.

South Suburban College Hospitality Management A.A.S. degree (61 credit hours) Hospitality Management Certificate (34 credit hours)

Program Purpose: These programs will prepare individuals for entry-level employment, and advancement opportunities, in the field of hospitality management.

Catalog Description: Hospitality Management A.A.S. degree - The Hospitality Management Associate in Applied Science (AAS) program will prepare students for entry-level or promotional opportunities in the field of hospitality. The program will enhance the students' education level and represent the foundation for higher levels of academics. Courses have been designed to provide students with the fundamental information, principles, theories, and techniques related to hotel, evens, and food service management necessary to work in the industry. Students gain an understanding of the structure and operations of the hospitality sector and related industries. Students will be introduced to real-world scenarios and case studies to enhance learning process; as well as, have an opportunity to conduct research and interviews of those who been successful within the industry.

Hospitality Management Certificate – The certificate in Hospitality Management will prepare students with some experience in the hospitality industry, including those with management experience, with the necessary skills to advance beyond supervisory positions. This program will go beyond the Basis Hospitality Management Certificate to offer business management and human resource management skills applicable for the hospitality industry.

Curricular Information: Hospitality Management A.A.S. degree - The curriculum includes 15 credit hours of required general education, and 47 credit hours of required career and technical education coursework. The career and technical component builds on the certificate curriculum to include additional general education, and career and technical education instruction in introductory hospitality and event planning, principles of marketing and management in hospitality, legal environment of business, supervisory and operations management, financial and managerial accounting, human relations in organizations, human resources management, front office operations, and a required hospitality management internship.

Hospitality Management Advanced Certificate – This curriculum includes nine (9) credit hours of general education coursework and 25 credit hours in required career and technical education coursework. Assessment of student learning will be achieved through evaluation of the student's performance during the work-based learning experience by program faculty and worksite supervisor. The proposed programs provide a continued educational ladder opportunity for students completing the College's recently approved Basic Hospitality Management Certificate program. Both curricula were developed according to the objectives set forth by the American Hotel & Lodging Association for supervisory and management positions, and ServSafe Food Handler standards. Both will prepare individuals for their Food Service Sanitation certification through the Illinois Department of Public Health (IDPH).

Accrediting Information: NA.

Justification for Credit hours required: The program was developed according to industry objectives and standards, and meets the recommendations of the program advisory committee for successful employment in local industry.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the interest in and the need for a degree program in this field of study. According to the Illinois Department of Employment Security (IDES), employment growth in related hospitality management occupation is expected to increase statewide between 4-12% through the year 2026.

Southwestern Illinois College

➤ Brewing Science & Operations Associate in Applied Science (A.A.S.) degree (60 credit hours)

BACKGROUND

Southwestern Illinois College Brewing Science & Operations A.A.S. degree (60 credit hours)

Program Purpose: This program will prepare individuals for entry-level employment in small and commercial batch brewery operations as well as for self-employment.

Catalog Description: The Brewing Operations & Fermentation Science program prepares students for a variety of jobs in the expanding brewing and beverage industry. This program will provide foundational knowledge for brewery operations, production procedures, and basic quality assurance. In partnership with 4204 Main Street Brewing Company, students will have access to the latest equipment and technologies used in the industry today and receive hands-on training through courses, capstone, and internship programs. The Associate of Applied Science (A.A.S.) degree will allow students to focus on the science and business portions of the curriculum to prepare graduates for entrepreneurial opportunities.

Curricular Information: The curriculum includes 15 credit hours of required general education, and 36 credit hour of required career and technical education coursework, and nine (9) related technical electives. The career and technical component includes instruction in introductory brewing processes, principles of brewing science, introductory and advanced brewing science operations, biochemistry of brewing, brewing technology, introductory fermentation science, beers & wines of the world, legal topics in brewing, sensory analysis of beer, occupational health and safety awareness, fork lift truck safety, food service sanitation, a brewing science capstone project, and a brewing operations internship. Assessment of student learning will be achieved through evaluation of the student's performance on the comprehensive capstone project by program faculty, and during the student's participation in the internship by their worksite supervisor. The program will prepare students for ServSafe Food Service Sanitation certification through the Illinois Department of Public Health (IDPH), and for licensure as a Fork Lift Operator through the Occupational Health and Safety Administration (OSHA).

Accrediting Information: Accreditation is not required, however, the Master Brewers Association of the Americas (MBAA) recognizes two- and four-year programs that meet their recommended guidelines and learning outcomes. The college crafted the curriculum based on MBAA recommendations and will be able to apply for their program accreditation once granted ICCB approval.

Justification for Credit hours required: NA.

Supporting Labor Market Data (including employer partners): Labor market information provided by the college supports the interest in and need for formalized training in this field in the college's district and surrounding area. The college worked closely with a local employer to develop curricula that would prepare individuals for entry-level employment, advancement, and entrepreneurial opportunities. As data specific to brewery operations is not currently collected by the Illinois Department of Employment Security (IDES), the college worked with local workforce development bodies to establish a warranted need for more workers trained for this field in the area. Those groups included the Madison County Employment & Training Office, St. Clair County Intergovernmental Economic Development Department, the Leadership Council of Southwestern Illinois, and the Southwestern Madison County Chamber of Commerce.

The Illinois Community College Board hereby approves the Board minutes of the April 10, 2020 meeting as recorded.

Item #1 - Roll Call and Declaration of Quorum

Per the Governor's Executive Order 20-07 (COVID-19 EXECUTIVE ORDER NO.5) the Board meeting will be conducted by a conference call only. Chair Lopez called the Board meeting to order at 12:02 p.m. and asked Ann Knoedler to call roll. The following Board members were present on the call: Paige Ponder, Terry Bruce, Teresa Garate, Nick Kachiroubas, Suzanne Morris, Doug Mraz and Isabella Hernandez, Student Board member. A quorum was declared.

Item #2 - Announcements and Remarks by Dr. Lazaro Lopez, Board Chair

Dr. Lopez thanked and extended his appreciation of the Governor's Office leadership team for their guidance and support of higher education during this difficult time. He then recognized all the ICCB staff for hard work in keeping the agency running as well as providing important system level guidance during the transition to work from home status. He expressed his appreciation for the staff's ability to issue important guidance to the field to help protect students during this difficult and confusing time.

➤ Board member comments: The Board members also all thanked the ICCB staff for their hard work and dedication to being very responsive and helpful to the field during this difficult time.

Item #3 – Executive Director Report

Dr. Brian Durham began by stating the ICCB transitioned all employees to a remote working environment, in the best interest of the health, safety, and well-being of the employees and their families, through the duration of the Gubernatorial Disaster proclamation. With that being said, Dr. Durham thanked all the staff for their hard work in making this a smooth transition and working diligently while in work from home status.

ICCB staff is in constant communication with the IL Board of Higher Education, IL Student Assistance Commission, the colleges, and the Governor's Office with constant updates and requests for more information. The agency has also worked with all 48 community colleges and grant programs to assist them as they moved to alternative, remote, or online instruction during the period of the Gubernatorial Disaster Proclamation (expires April 30, 2020).

A big concern with the community college presidents was continuing to pay their employees while the working from home order was enforced. Agency staff worked with the Governor's Office to ensure that all part-time and full-time personnel across community colleges and grant programs continue to be paid through the Spring semester.

Dr. Durham communicated directly with community college presidents, holding five calls per week with separate geographically positioned groups of presidents to troubleshoot any issues or concerns they might encounter. This provided the opportunity for the groups to discuss any developing issues or concerns as they moved to alternative, remote, or online instruction, and facilitated conversations between them about their current circumstances. This also gave agency staff the chance to issue system level guidance on the impact of Governor Pritzker's "Stay at Home" Order and previous developments related to the COVID-19 pandemic as they progressed.

One of the most important conversations was the guidance the ICCB provided to the community college system on the implementation of the federal Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

The agency has also been involved in the following many efforts:

Surveys

- Created an ICCB online survey for submission of questions and concerns related to COVID-19, which are researched and answered then posted to a continuously updated Frequently Asked Questions section of the ICCB website.
- ➤ Collaborated with the COVID-19 Education Response Group to survey institutions to assist SEOC in discovering available resources to support first responders, healthcare services, or community emergency needs. Resources sought included spaces for temporary housing, food service, cleaning supplies and staffing, and lab technology.

Collaborated Efforts

- ➤ Communicated with legislators, alongside Illinois Board of Higher Education (IBHE) and Illinois Student Assistance Commission (ISAC), to answer questions and summarize higher education's response to the COVID-19 pandemic.
- ➤ Created an ICCB COVID-19 website to provide resources and guidance to the community colleges, adult education system, grantees, and other stakeholders. In addition to serving as a repository for guidance and recommendations issued by the ICCB, the website includes resources from state and federal agencies.
- Collaborated on the development of a map (in progress) of available drive-up WI-FI hotspots at schools, colleges, extension sites, and libraries across the state.
- ➤ Drafted, with IBHE, guidance about the implementation of dual credit for K-12 students in the higher education system, ensuring that a "do no harm" approach is adopted by colleges and that students are afforded every protection possible to protect their academic standing, consistent with the statutory authority afforded through the Dual Credit Quality Act.
- ➤ Drafted, with IBHE, and the Illinois Articulation Initiative (IAI) guidance on Pass Fail grading and a companion legislative proposal, as well as Guidance on Advanced Placement and International Baccalaureate Scores for Spring 2020, to protect community college student transfer opportunities in the future.

Adult Education

- Suspended all Adult Education and Literacy instruction through March 31st, with a transition to online instruction beginning on April 1 and continuing during the period of the Gubernatorial Disaster Proclamation.
- Suspended High School Equivalency Testing until the end of the Gubernatorial Disaster Proclamation.

- Suspended 45% instructional generation requirements for Adult Education to provide maximum flexibility to programs in responding to the pandemic.

FISCAL YEAR 2019 DUAL CREDIT REPORT

Dual credit is an instructional arrangement where an academically qualified high school student enrolls in a college-level course and, upon successful course completion, concurrently earns both college credit and high school credit. The Illinois Community College System recorded a total of 64,106 high school students enrolled in dual credit courses during fiscal year 2019. Currently, all Illinois community colleges offer dual credit courses. Annual dual credit enrollments increased 8.6 percent compared to the previous year (N = 59,039) and 24.0 percent compared to five years ago (N = 51,718). Among Illinois' 48 colleges, 22 colleges reported more than 1,000 dual credit enrollments in fiscal year 2019. College of DuPage reported the most dual credit enrollments (N = 5,771), followed by Joliet Junior College (N = 4,560) and Harper College (N = 3,915).

SENATE JOINT RESOLUTION 41 REPORT

The Illinois Community College Board (ICCB) and the Illinois Board of Higher Education (IBHE) submitted the Inventory of Developmental Education in Public Community Colleges and Universities in Illinois Report on March 31, 2020 to the Illinois Governor and Legislature in compliance with Senate Joint Resolution (SJR) 41 (adopted in spring of 2019).

An SJR 41 Advisory Council is convening throughout 2019-20 for the purposes of reviewing and scaling effective developmental education practices. The Advisory Council provided feedback and guidance as part of the *Inventory of Developmental Education in Public Community Colleges and Universities in Illinois Report*. The report includes:

- (1) An inventory of all instructional models and developmental course sequences employed by Illinois' public colleges and universities for students placed into developmental education or otherwise determined to need additional skills development in math or English;
- (2) An analysis of all instructional models employed by Illinois' public colleges and universities for students placed into developmental education or otherwise determined to need additional skills development in math or English, including, at a minimum, the number and percentage of students completing gateway courses within their first two semesters under each model; and
- (3) An inventory and analysis of developmental education placement practices and policies (including cut off scores) employed at all public colleges and universities.

The statewide inventory report will be used by the SJR 41 Advisory Council to develop an implementation plan for public higher education by July 1, 2020. Entering this information on developmental education into the public record is important to providing a baseline of knowledge for this current work and to future efforts to continuously improve public higher education in ways that benefit all residents of Illinois.
