PROGRAM DELIVERABLES

The following deliverables are required for the Adult Education and Leadership Technical Assistance Program. Directions for submitting proposals are identified in the Grant Application Section.

Support for Workforce-Aligned English Language Acquisition Instruction, including Evidence-Based Reading Instruction, Assessment, and Instructionally Embedded Technology Integration, delivered through In Person, On Site, and Virtual Support.

- Coordinate and deliver professional development and technical assistance to WIOA Title II providers related to the English Language Acquisition Content Standards, aligned with workforce readiness foundational contexts.
- Coordinate and deliver ELL NRS Assessment Training to WIOA Title II providers.
- Coordinate and deliver the Evidence Based Reading Instruction for the Illinois Professional Development Network.
- Coordinate and deliver professional development and technical assistance for Technology Integration by embedding technology and AI utilization within ELA instructional training and coaching, rather than providing standalone or isolated technology or AI tool training, to support workforce-focused instructional practice.
- Support the Integrated English Language and Civics Education Program.
- Support Workplace Literacy Programs designed for English Language Acquisition.
- Engage with the Illinois Adult Education Professional Development Network Partners to coordinate offerings, including courses in the iLEARN system and conference events.
- Assist the ICCB Division of Adult Education with projects related to English Language Acquisition for the workforce, technology integration, and Evidence Based Reading instruction.
- Assist the ICCB Division of Adult Education in maintaining, analyzing, and reporting professional development participation data, including participation rates across funded programs, to identify trends, gaps in engagement, and opportunities for targeted technical assistance and continuous improvement.

Promote and Maintain the Illinois Adult Education Hotline.

- Maintain the Adult Education Hotline through managing customer-based phone calls, text messages, and online forms to connect potential adult learners with ICCB Funded Adult Education Programs.
- Identify and implement strategies to integrate AI into the hotline to support learners and improve sustainability.
- Promote the Hotline through social media posts and other relevant outreach strategies.

FUNDING INFORMATION

This grant is provided through the Illinois Community College Board. Funding available, up to \$300,000.00.

The grant period is July 1, 2026, through June 30, 2028. A renewal plan must be submitted in the Spring of 2027, and funding for the second year is contingent upon sufficient appropriation and a program’s satisfactory performance in the preceding year.

All grant funds shall be subject to the Illinois Grant Funds Recovery Act (30 ILCS 705). All funds granted for the operation of this program must be used exclusively for the purposes stated in the approved proposal and must be expended in accordance with the approved budget and the grantee’s policies and procedures related to such expenditures. Funds may only be expended for activities occurring during the grant period.

ELIGIBILITY INFORMATION

To be eligible, an applicant must be in the state of Illinois, in good standing with Illinois, and be

- Local Educational Agencies (LEAs)
- Institutions of Higher Education (IHEs)
- Public or Private nonprofit agencies

To be considered for funding under this AEL PDN TA Request for Proposal, an applicant of demonstrated effectiveness must include experience in several of the following areas, as appropriate to the scope of the proposed services:

- A minimum of 3 years of professional development and technical assistance for programs serving adult education and literacy.
- A minimum of 3 years of experience in providing professional development on topics related to at least 3 of the following: 1) the Workforce Investment and Opportunity Act, 2) service integration, 3) English Language Acquisition, 4) workplace literacy, and 5) curriculum and instruction, leading to increased student outcomes.
- Experience supporting Workplace Literacy and/or incumbent worker education initiatives, including English Language Acquisition instruction delivered in workforce or employment-aligned contexts.
- Ability to travel on-site to funded programs and provide targeted technical assistance.



- Demonstrated capacity to manage a multilingual hotline’s recruitment/awareness tool to connect potential adult learners to Title II-funded Adult Education Programs.

Funding for this project is contingent upon a sufficient federal appropriation and the program’s satisfactory performance in the preceding year.

- Applications from applicants that do not meet the eligibility criteria.
- Applications that are incomplete in any way or include unallowable uses of funds. *Uses of funds should follow federal EDGAR guidelines.*

Unique Entity Identifier:

Applicants will need their Unique Entity Identifier (UEI) and System for Award Management (SAM). Each applicant (unless the applicant is an individual or Federal or State awarding agency that is exempt from those requirements under 2 CFR § 25.110(b) or (c), or has an exception approved by the Federal or State awarding agency under 2 CFR § 25.110(d)) is required to:

APPLICATION PACKAGE MATERIALS

Applications submitted under this grant program will undergo a merit-based review process. All parts of the application package must be completed by the deadline to be considered. Applicants should ensure that all elements are clearly addressed and are strongly encouraged to use headers to address all elements or some consistent form of response delineation. Applicants will receive a receipt of application. However, applicants will not be notified if there are items that are missing from their application. - **Uniform Grant Application** – Applicants must record the FY2027 request with appropriate signatures from the Chief Executive Officer.
- **Uniform Grant Budget** – Applicants must record the FY27 requests under the appropriate line item listed on the attachment. The budget should include the FY27 requested amount only. The Chief Executive Officer must sign the Certificate worksheet within the Uniform Budget.
- **Scope of work**- Applicants must download the scope of work document via Amplifund with appropriate answers for each tab and submit the scope of work document via Amplifund.
- **Programmatic Risk Assessment** - Applicants must submit a Programmatic Risk Assessment via Amplifund.
- **FFATA Reporting** - Applicants are required to submit a FFATA form within Amplifund in accordance with Federal regulations.
- **Grant Narrative** - Applicants must complete the Grant Narrative within Amplifund by providing detailed responses in the designated sections. Applicants are required to download the narrative and upload it as a word document with their appropriate answers.

1. **Strategies for providing program support for English Language Acquisition, Technology Integration, Assessment, Evidence Based Reading Instruction, and ELA Workplace Literacy.** Discuss how the

applicant will provide a series of professional development training events, both virtually and in-person, for adult education instructors, administrators, and support staff focused on improving student outcomes for English Language Acquisition (workforce training focused), NRS Assessment, technology integration, and Evidence Based Reading Instruction.

Identify the applicant's capacity and staff experience for providing the required professional development.

2. **Services to Be Provided**

Provide a comprehensive proposed calendar of events which addresses the following:

- In person and virtual professional development training sessions in each of the required content areas (English Language Acquisition, NRS assessment, Evidence Based Reading, Technology Integration, and ELA Workplace Literacy).
- In person and virtual Institutes (seminars) related to the English Language NRS Assessments, Evidence Based Reading, Technology Integration, and ELA Workplace Literacy.
- Participation in the Adult Education conferences – The Annual Forum for Excellence, IACEA, and the WIOA Summit.
- Assist the ICCB by providing regular summaries of professional development participation, including analysis of engagement trends and identifying strategies to support programs with low participation.
- On-site (ICCB Title II Providers) technical assistance for programs based on ICCB's Request.
- Sharing promising practices by highlighting success.

3. **Indicators of Performance**

- Discuss how professional development and technical assistance will be evaluated using a comprehensive evaluation framework.
- Identify how the transference of learning from participants will lead to improved student outcomes.

4. **Hotline**

- **Infrastructure:** Discuss the Proposed Hotline's infrastructure. Identify how individuals will access the hotline (text messaging, online forms, phone calls). Discuss the hours of operation and the supports for English Language Learners. Identify how leads will be shared with Title II Adult Education Providers and how the information will be tracked.
- **Outreach:** Discuss how the hotline will be promoted

All applicants must complete the required narrative fields within Amplifund. Failure to provide complete and detailed responses may result in application disqualification.

SCOPE OF WORK

Programs must also complete the Scope of Work section within Amplifund. This section outlines the expectations for quarterly performance tracking and data reporting. All Scope of Work fields must be completed within Amplifund to ensure compliance with ICCB reporting and performance monitoring requirements.

APPLICATION REVIEW

Applications will be reviewed using a merit-based review process (2 CFR 200.204) using a committee of experts in the field of adult education and professional development. A rubric will be used to assess the extent to which the applicant meets the criteria in each category. The point breakdown is as follows:

Professional Development, Technical Assistance, and Hotline Services/ 100 points maximum

- **30 points:** Strategies for providing program support for ELA, workforce-aligned instruction, technology integration, assessment, and Evidence Based Reading Instruction.
- **25 points:** Applicant's capacity and staff experience.
- **20 points:** A comprehensive calendar of services and activities, including professional development, technical assistance, and hotline operations.
- **20 points:** Indicators of Performance and continuous improvement.
- **5 points:** Budget

Merit-Based Evaluation Appeal Process

- Competitive grant appeals are limited to the evaluation process. Evaluation scores may not be protested. Only the evaluation process is subject to appeal.
- An appeal must be received within 14 calendar days after the date that the grant award notice has been published.
- Response to Appeal: ICCB will acknowledge receipt of an appeal within fourteen 14 calendar days from the date the appeal was received and will respond to the appeal within 60 days or supply a written explanation to the appealing party as to why additional time is required.

AWARD NOTIFICATION AND ADMINISTRATION

- a. An award shall be made pursuant to a written determination based on the evaluation criteria set forth in the grant application and successful completion of finalist requirements.
- b. A Notice of State Award (NOSA) will be issued to the Merit Based finalists that have successfully completed all grant award requirements. Based on the NOSA, the Merit Based finalist is positioned to make an informed decision to accept the grant award.
- c. Upon acceptance of the grant award, announcement of the grant award shall be published by the awarding agency to Grants.Illinois.gov.
- d. A written Notice of Denial shall be sent to the applicants not receiving awards.
- e. Upon acceptance of the NOSA, the awardee will receive a Uniform Grant Agreement. This Agreement must be signed by an authorized signatory and returned to the ICCB prior to any expenditure of funds.
- f. Funds may be requested at any interval upon return of the Uniform Grant Agreement.

REPORTING

The funded program will provide programmatic and expenditure quarterly reports to the ICCB, identifying the programmatic outcomes, participation metrics, challenges, and strategies for addressing them. Quarterly expenditure and quarterly performance reporting will use the schedule stipulated in the grant agreement.
