WHAT IS THE TRANSFER RATE FOR ILLINOIS COMMUNITY COLLEGE STUDENTS?

Illinois is a national leader for students enrolled in community college transfer to four-year institution programs. Much of this can be attributed to the strong statewide articulation mandate (the [Illinois Articulation Initiative](#)) that facilitates transfer of courses between more than 100 Illinois community colleges and four-year institutions.

Students enroll at community colleges for a variety of reasons which could include transfer to a four-year institution, earning a certificate or degree that leads to direct employment in high demand fields, or completing courses to upskill with a current employer. Transfer programs are the largest instructional program area for Illinois community colleges and specifically provide a smooth transition to a senior institution for students planning to complete a bachelor’s degree. All community college districts offer an Associate in Science (A.S.) and Associate in Arts (A.A.). The A.S. is for students planning to major in math, science, or health related areas, and the A.A. is an appropriate degree for students planning to major in the liberal arts.

The Transfer Rate in Table 1 measures the success of students earning an Illinois community college associate degree specifically designed to transfer to a four-year institution. The methodology tracks students who complete an associate degree and then transfer within one year post graduation to a four-year institution. The table provides detail on if students transfer to an Illinois 4-year institution and/or out-of-state 4-year institution. Transfer Rates are calculated for all students completing associate degrees during fiscal years 2018 through 2021.

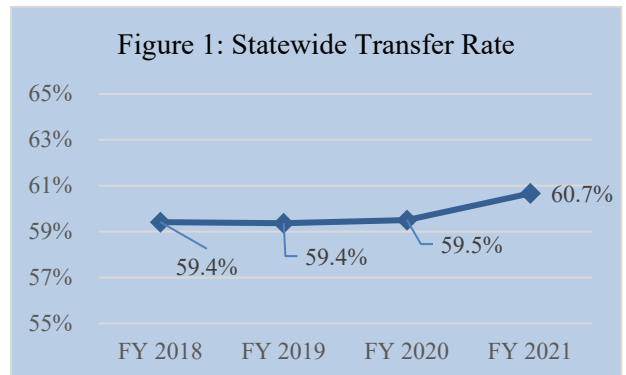

Of note, the majority of students that transferred are remaining in Illinois. For FY 2021, of the 11,532 students that enrolled in a 4-year institution nearly 77.8 percent (N = 8,968) were in Illinois. An additional 1.4 percent (N = 157) enrolled in both an Illinois and out-of-state 4-year institutions within a year of graduation.

The Transfer Rate remained fairly consistent during fiscal years 2018 through 2021 as seen in Figure 1, with around 60 percent of associate degree completers enrolling in a four-year institution within one year. The most current year did have a 1.2 percent increase compared to the prior year (60.7 percent in FY 2021 versus 59.5 percent in FY 2020)
